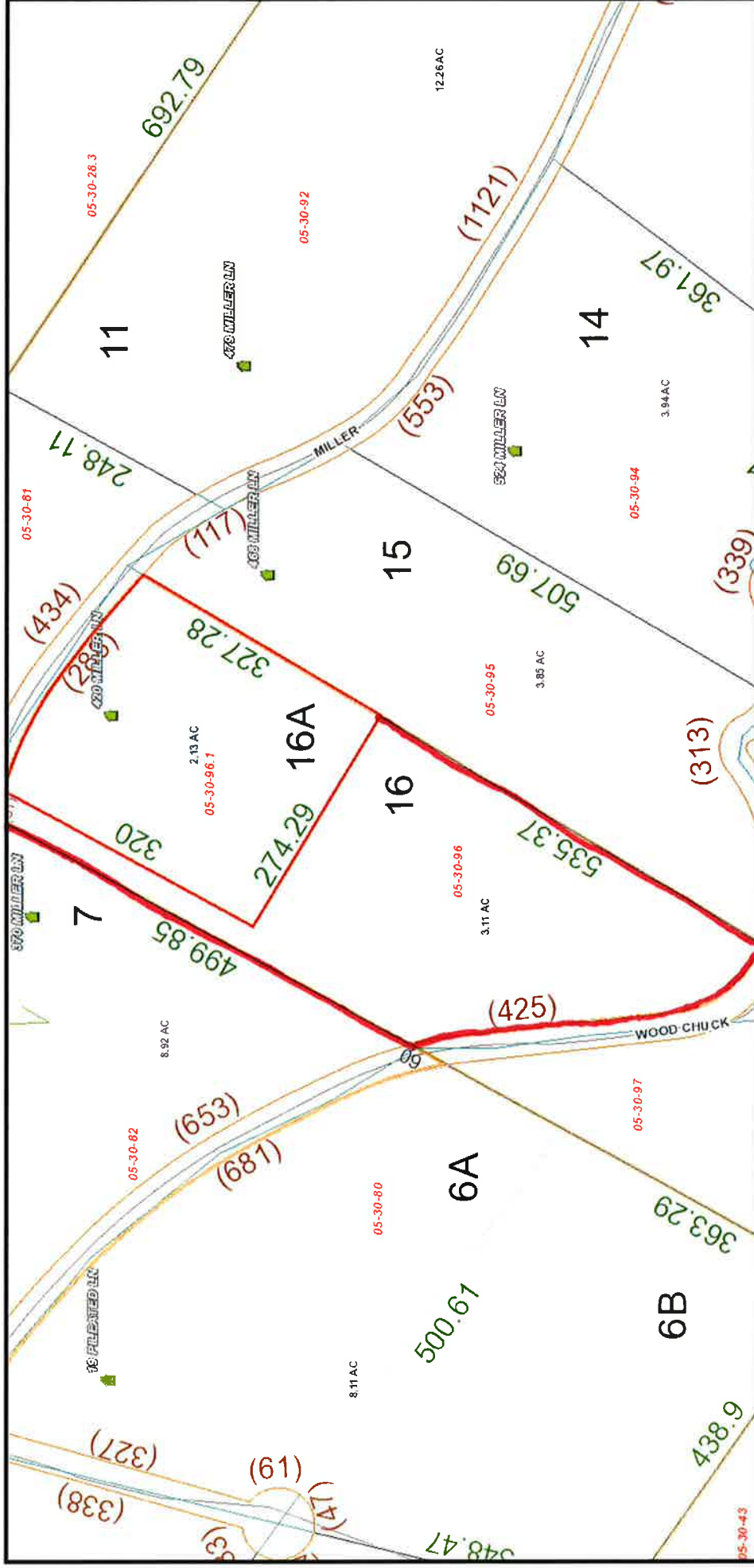


## Hampshire County, WV PROPERTY MAP

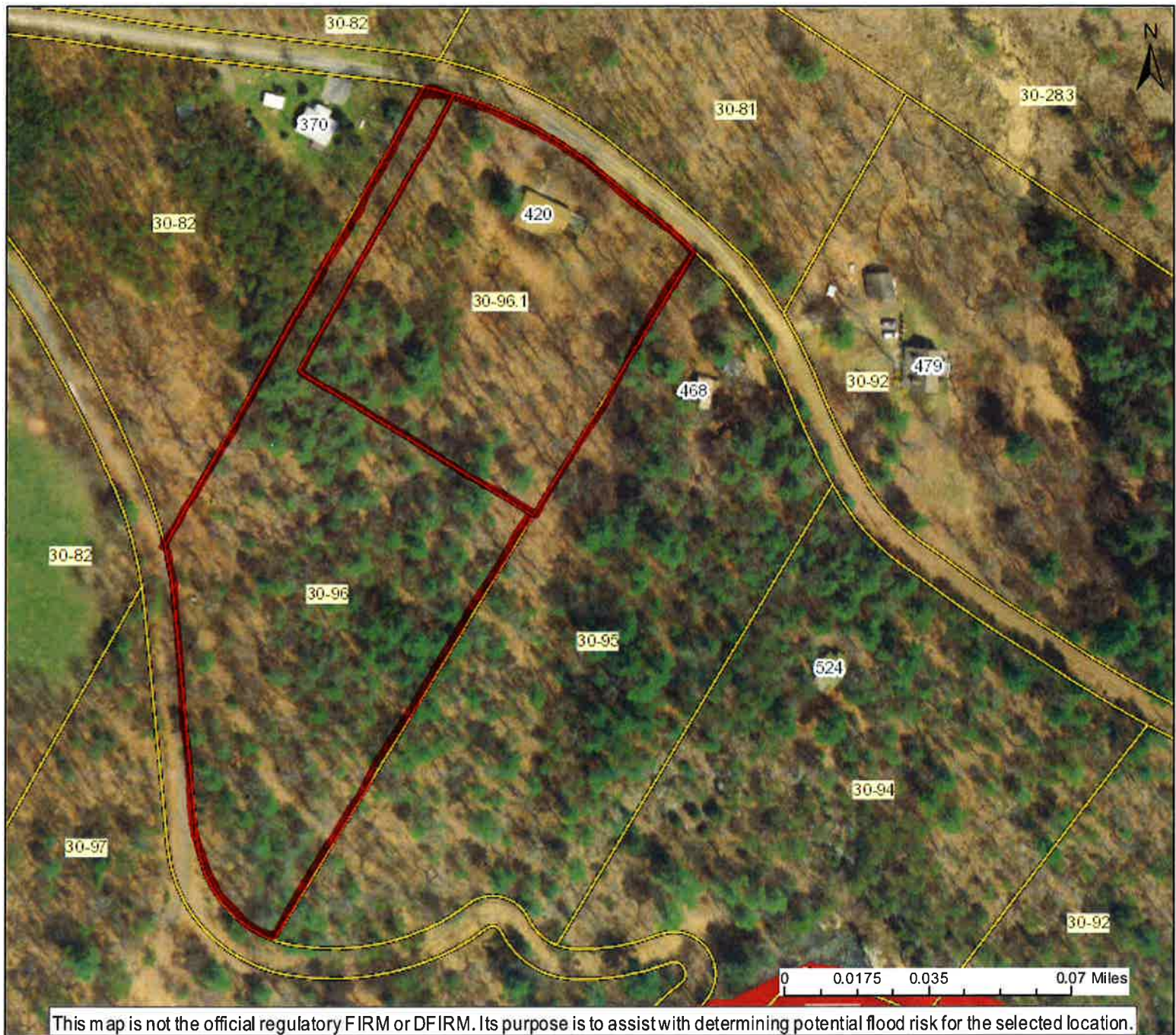

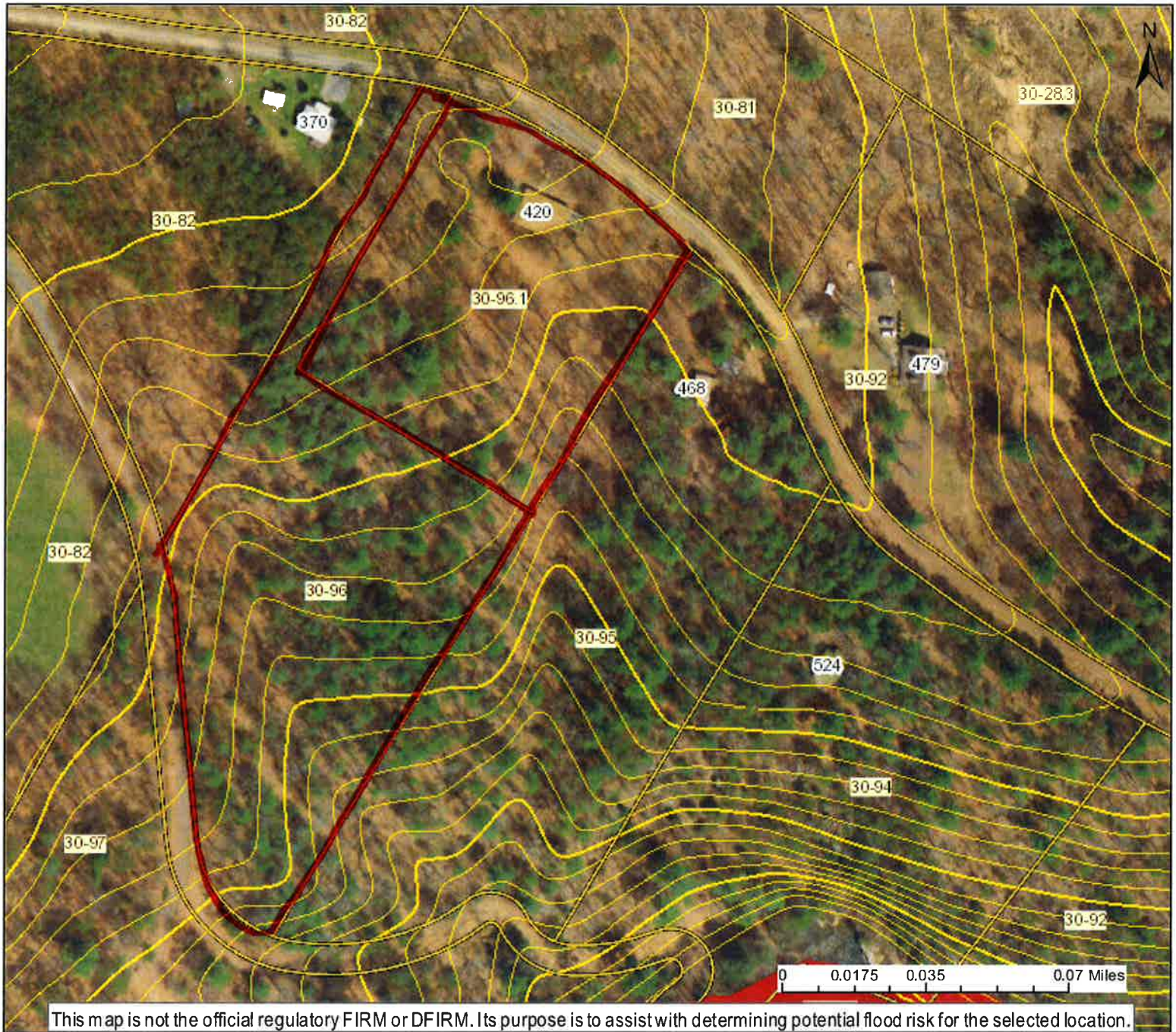
