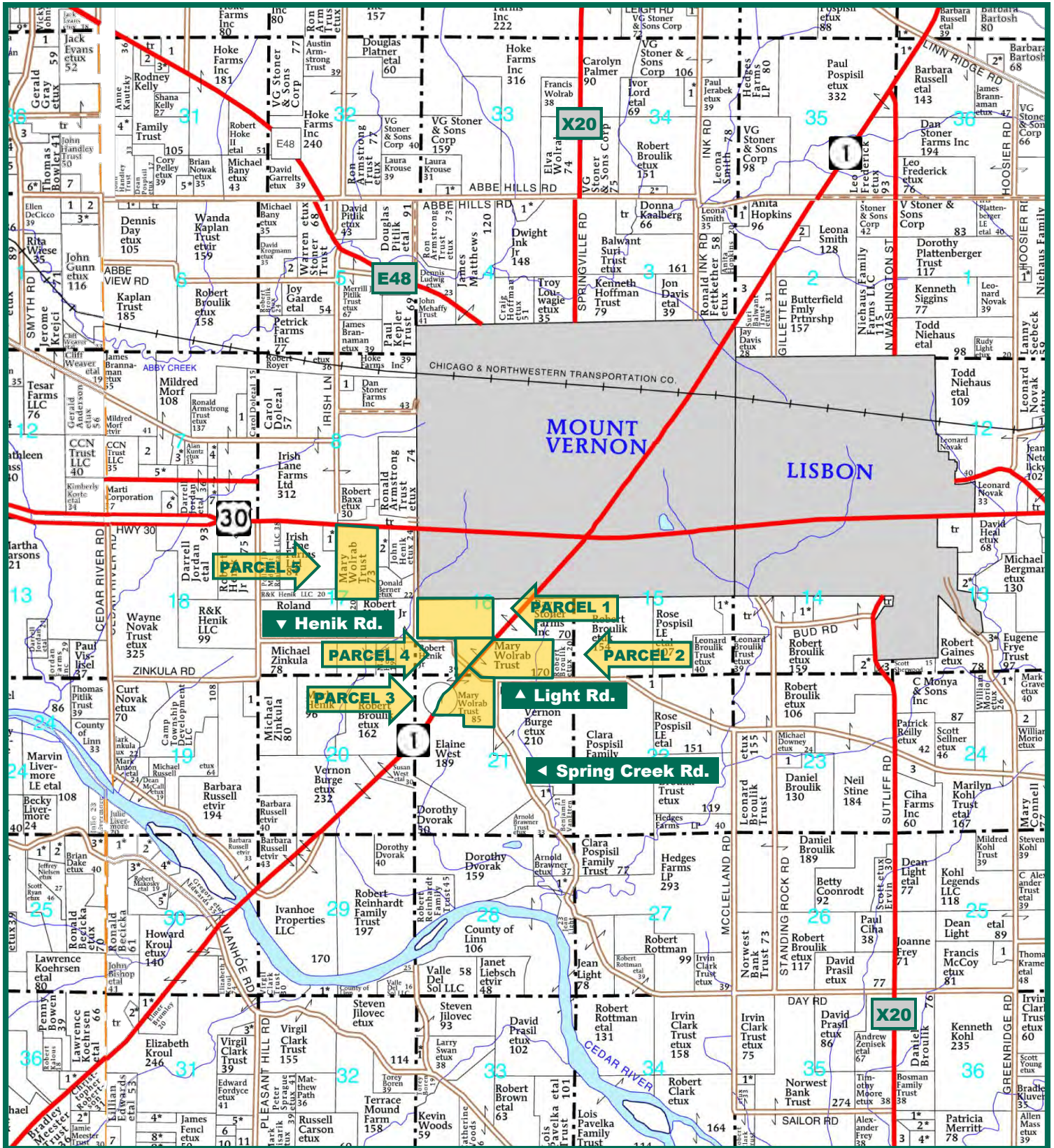

Plat Map: All Parcels

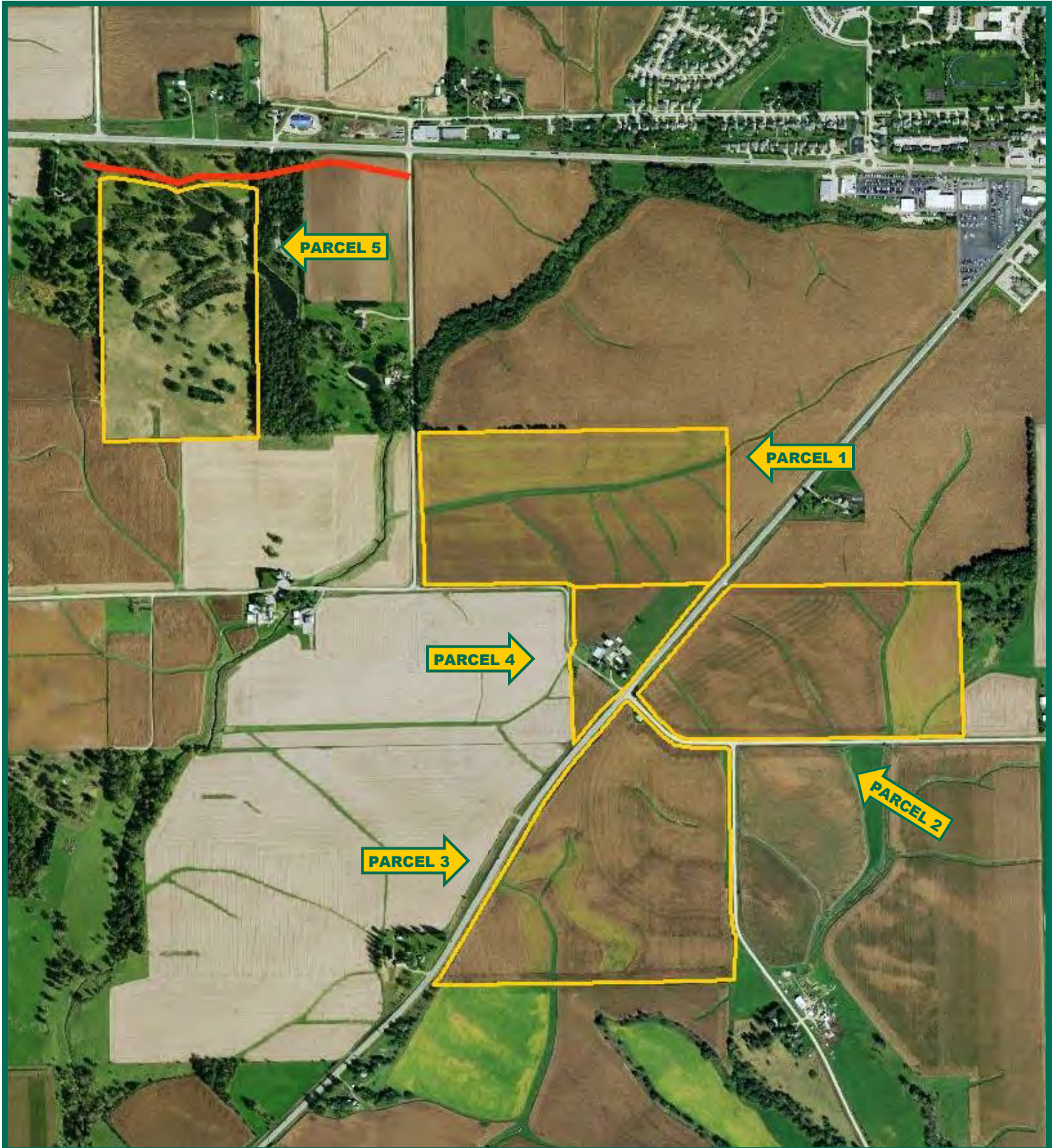

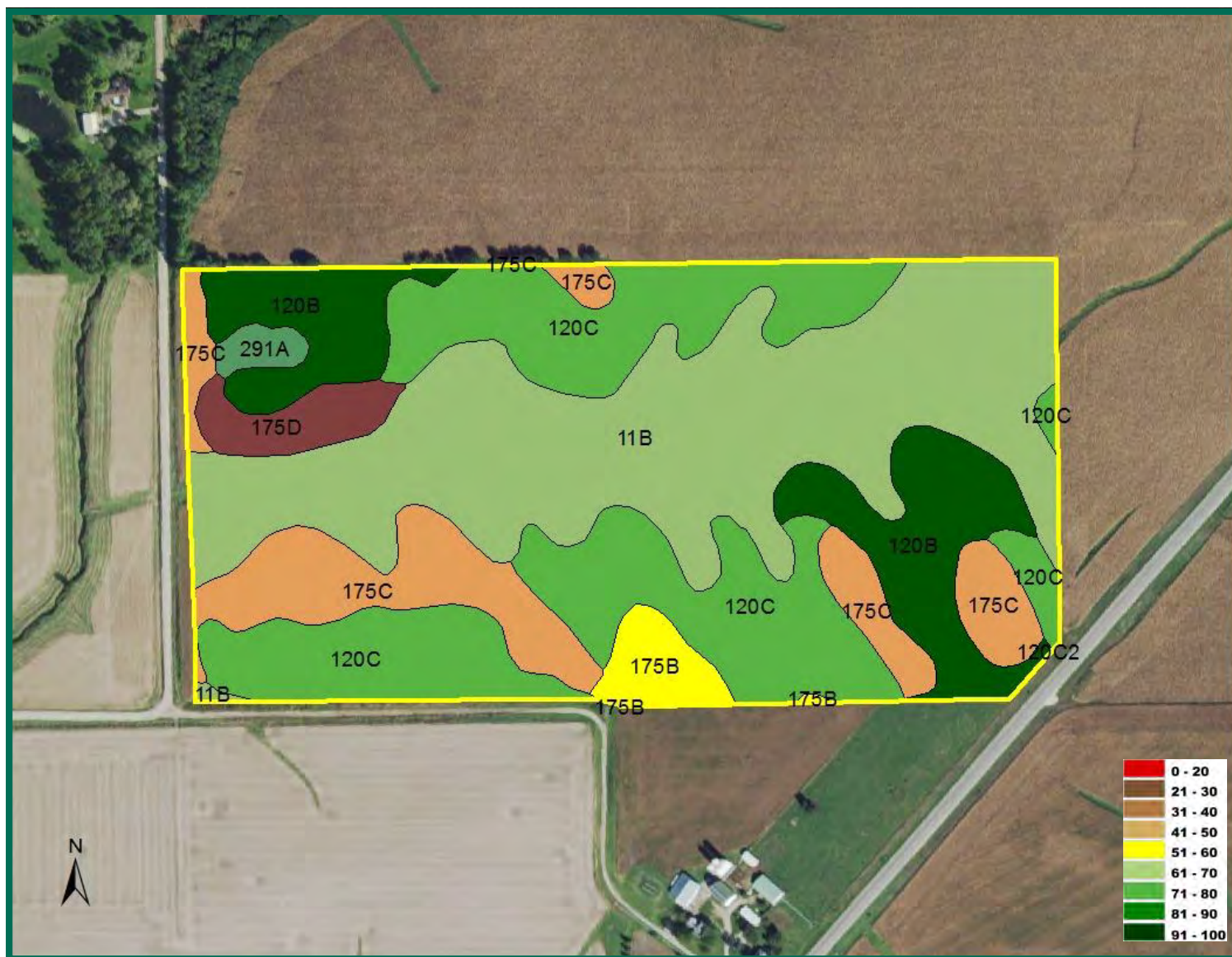

Soil Map: Parcel 1

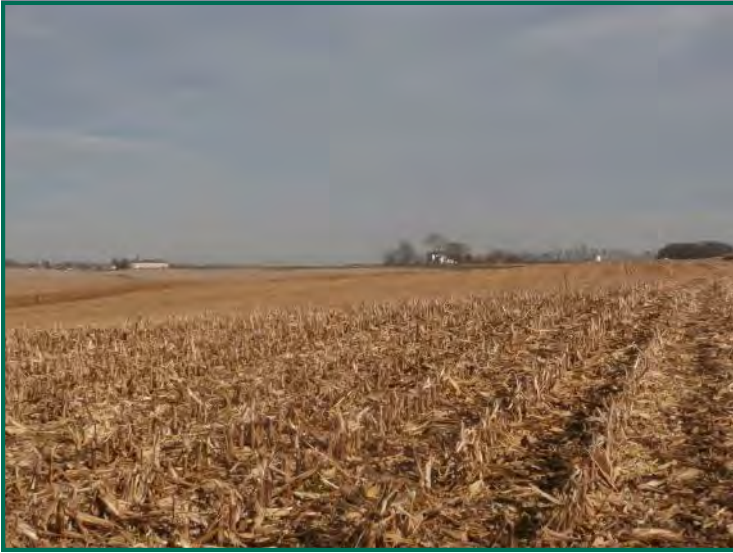

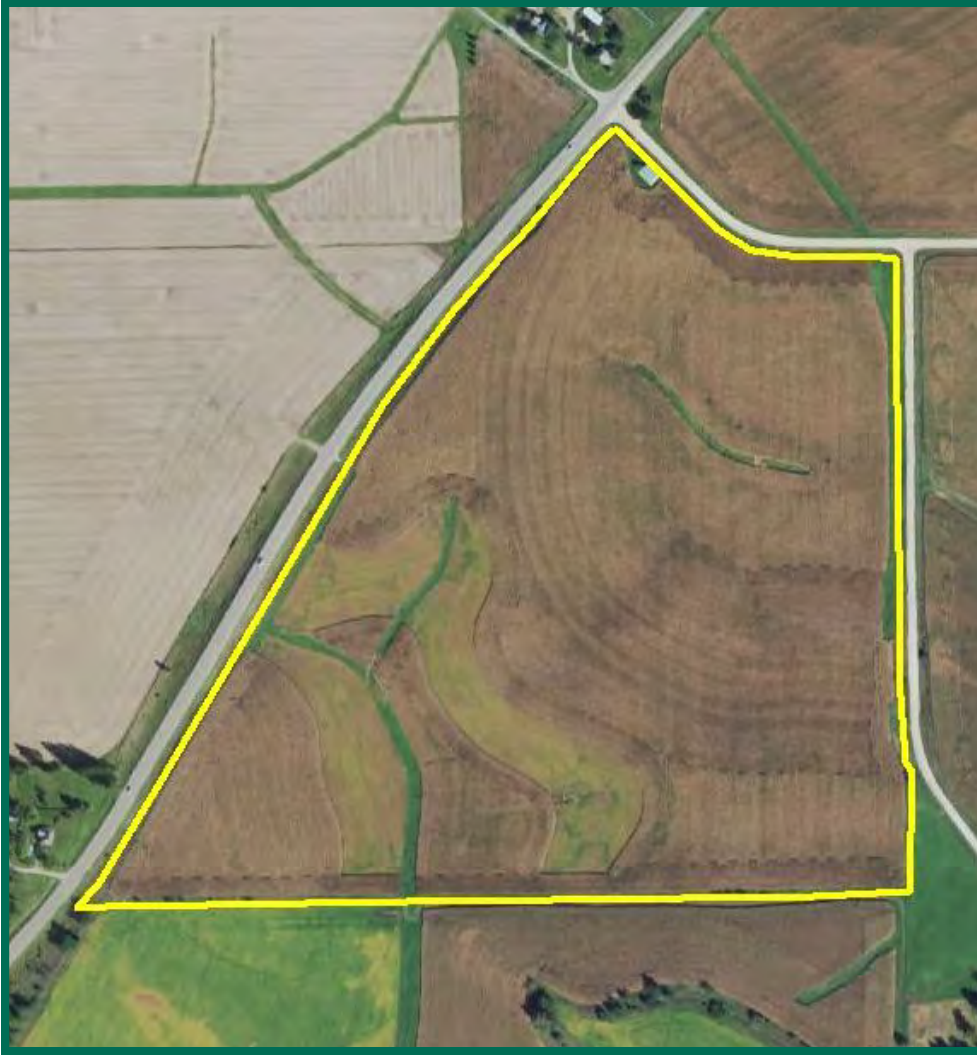

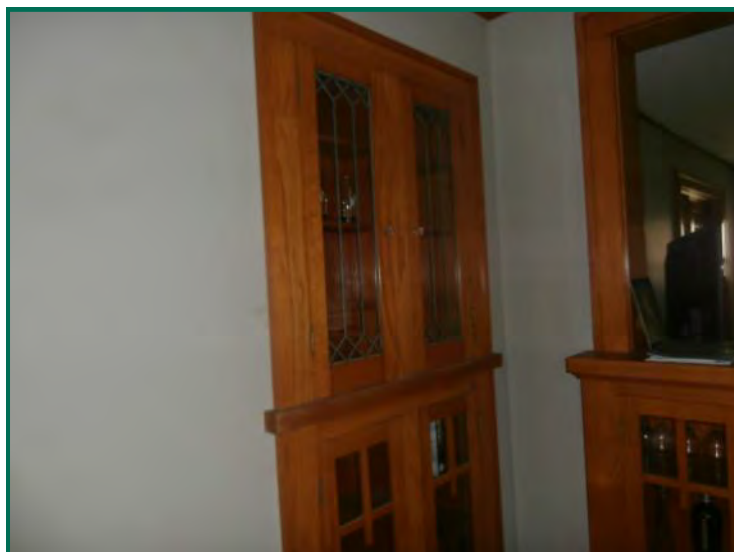

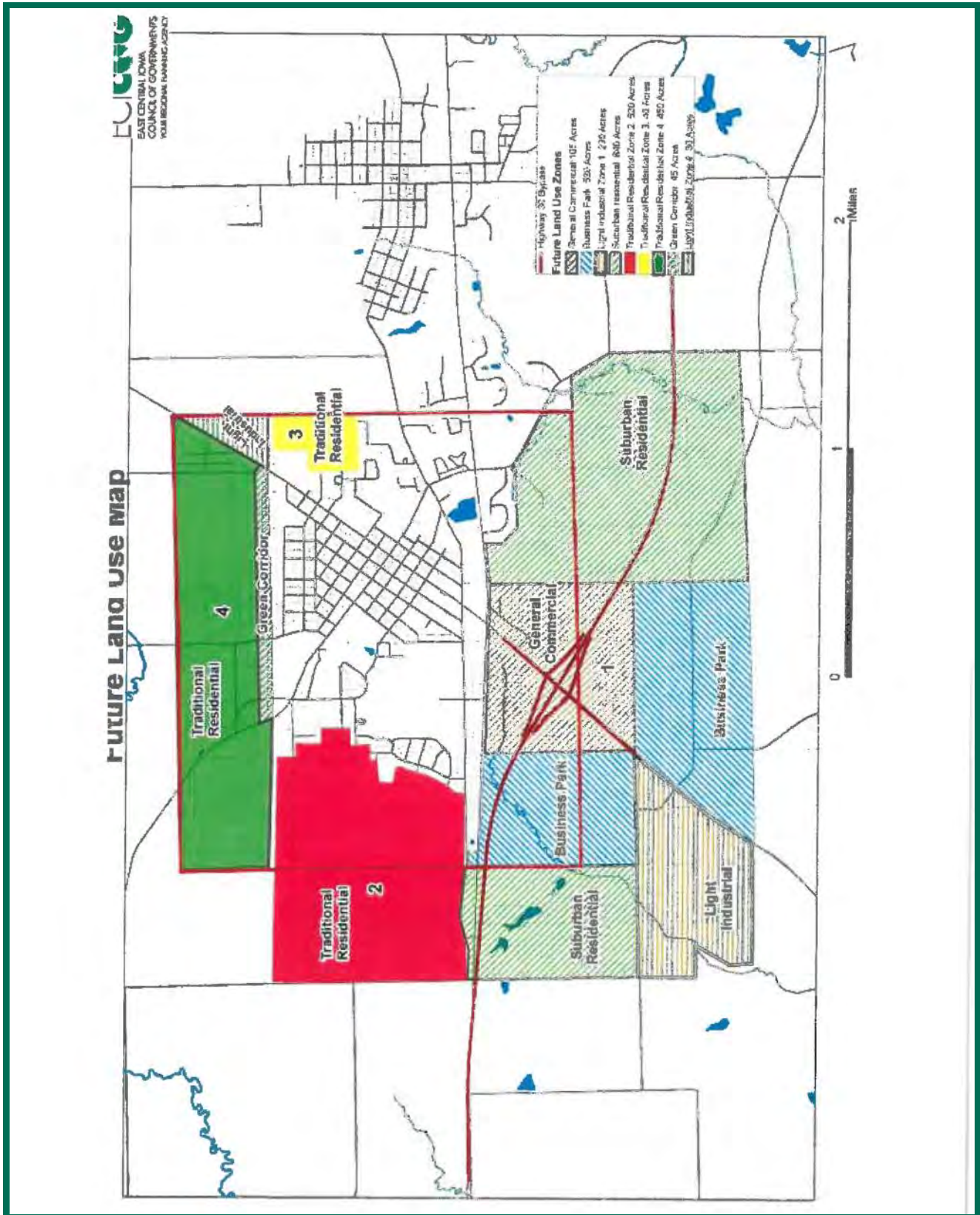
Aerial Photo: Future Access Road
