Location: The **Kokomo Creek Tract** is located three (3) miles southwest of Malvern and is described as Part of frl. <u>Tract Description</u>: Timber consists of native pine / hardwood of good quality. Access is via deeded easements from Webster Trail and Upper Etta Road (more information on website). Pine site index averages eighty-seven (87) feet (base age 50) on silt loams and fine sandy loams. Tract offers immediate timber harvesting with deer and duck hunting opportunities.






