Take the second right as you come into Forest City. You will go over railroad tracks. Continue down that road until you get to the first entrance of Bob Brown Wildlife refuge. Turn right and follow that road until the gravel ends. It will be your first pond on the left.

#### **IMPROVEMENTS:**




