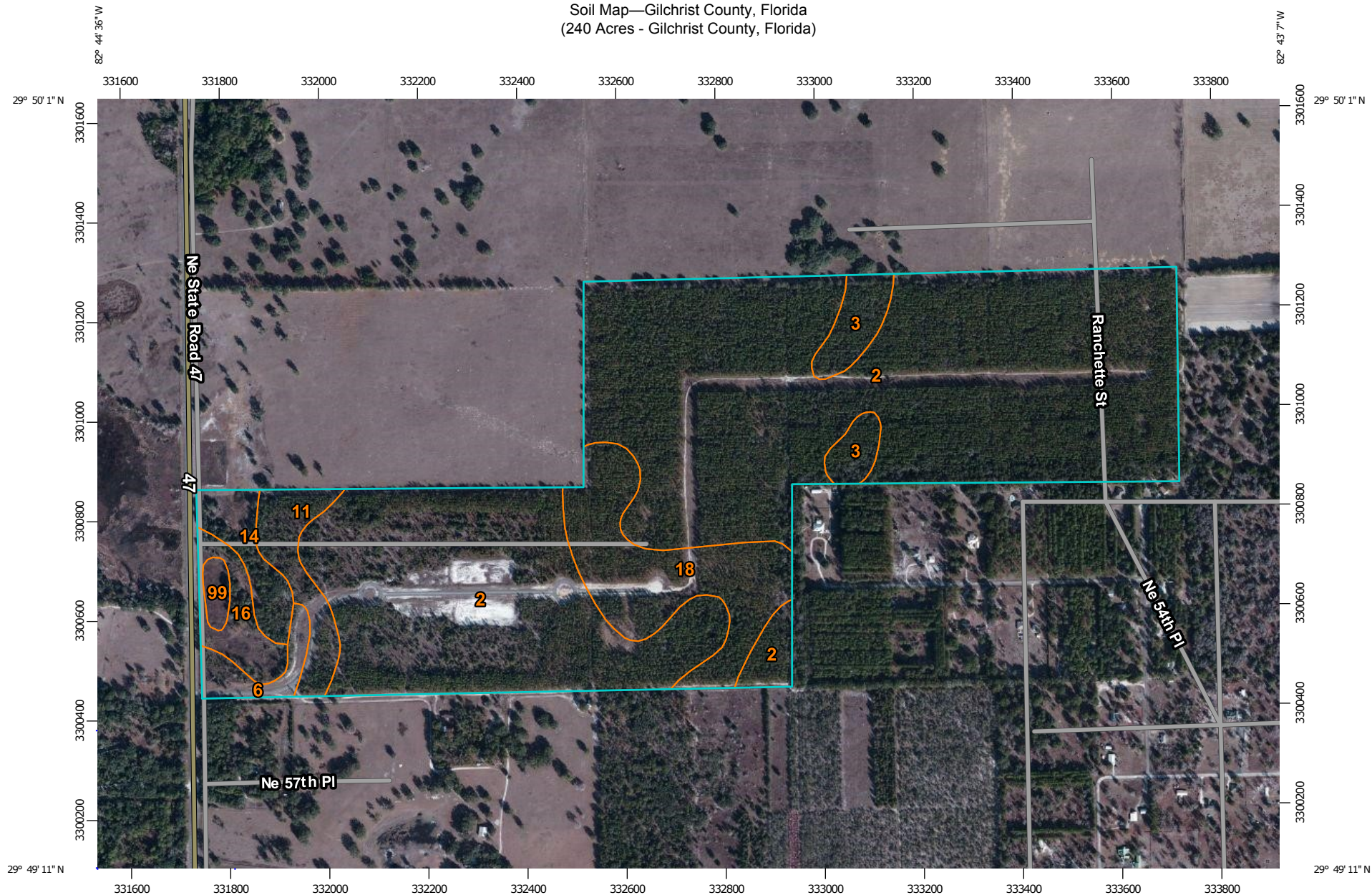
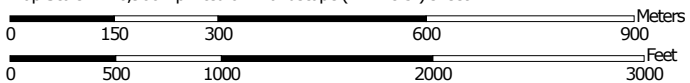


Soil Map—Gilchrist County, Florida
