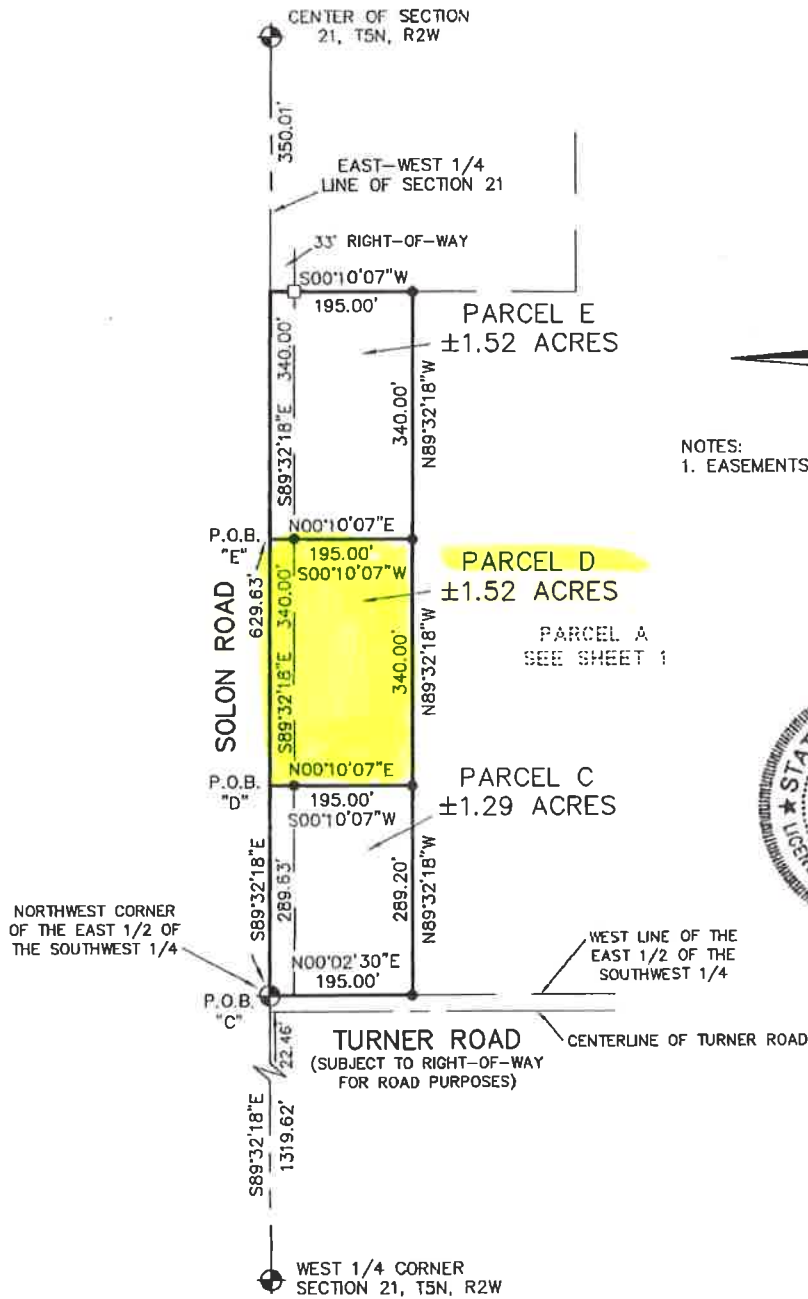


CERTIFIED BOUNDARY SURVEY

Parcel C: A parcel of land in the Southwest 1/4 of Section 21, T5N, R2W, DeWitt Township, Clinton County, Michigan, the surveyed boundary of said parcel described as: Commencing at the West 1/4 corner of said Section 21; thence S89°32'18"E along the East-West 1/4 line of said Section 21 a distance of 1319.62 feet to the Northwest corner of the East 1/2 of said Southwest 1/4 and the point of beginning of this description; thence continuing S89°32'18"E along said East-West 1/4 line 289.63 feet; thence S00°10'07"W 195.00 feet; thence N89°32'18"W parallel with said East-West 1/4 line 289.20 feet to the West line of the East 1/2 of said Southwest 1/4; thence N00°02'30"E along said West line 195.00 feet to the point of beginning; said parcel containing 1.29 acres, more or less; said parcel subject to right of way for road purposes along Turner and Solon Roads; said parcel subject to all easements and restrictions if any.
