THENCE, South 87 Degrees 07 Minutes 56 Seconds West, passing a West line of said 35.160 acre tract, and an East line of said 34.500 acre tract, and continuing the same course in all a total distance of 229.20 feet to a 1/2 inch iron rod set marked (CBG INC) for corner in a West line of said 34.500 acre tract, and in the East line of the remainder of a 43 acre tract of land conveyed to L. M. Smith, by deed recorded in Volume X-7, Page 124, Deed Records, Cass County, Texas, from said point, a cross-tie fence post found, bears South 00 Degrees 51 Minutes 10 Seconds East, a distance of 545.50 feet;
