DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS

WHEREAS, KAPLAN will convey Lot 2 of the Kaplan Ranch Subdivision according to a map or plat thereof recorded in Volume 9, Page 313, Comal County, Texas Map and Plat Records above described to Edward A. Hundley and wife, Connie P. Hundley, hereinafter called HUNDLEY, subject to certain protective covenants, conditions, and restrictions, as hereinafter set forth; and

WHEREAS, HUNDLEY has required as part of the consideration for the sale and conveyance of Lot 2 that KAPLAN similarly encumber and restrict all of the remaining property owned by KAPLAN and described in Exhibit "A" attached hereto with the same protective covenants, conditions, and restrictions; and

NOW, THEREFORE, it is hereby declared that all of the Property described herein shall be held, sold, and conveyed subject to the following restrictions, covenants, and conditions, which are for the purpose of protecting the value and desirability of, and which shall run with the Property and shall be binding on all parties having right, title or interest in or to the above described Property or any part thereof, and their heirs, successors, and assigns, and which restrictions, covenants, and conditions shall inure to the benefit of each owner thereof.

SEVERABILITY

Invalidation of any one of these covenants, conditions, or restrictions by judgment or court order shall in no way affect any other provision, and all other provisions shall remain in full force and effect.

III.

ENFORCEABILITY

This Declaration may be enforced by KAPLAN, HUNDLEY, and their respective heirs, successors and assigns, and the owner of

all or any part of the Property, and their heirs, executors, administrators, successors and assigns.

TV.

DURATION AND AMENDMENT

The covenants, conditions and restrictions provided for in this Declaration shall run with and bind the land and shall inure to the benefit of and be enforceable by KAPLAN, HUNDLEY, or any other owner of any part of the Property subject to these Declarations, their respective heirs and successors and assigns, for a term of twenty-five (25) years from the date this Declaration is recorded, after which time the same shall be automatically extended for successive periods of ten (10) years. Except as hereinabove expressly provided, the provisions hereof may be amended only by an instrument signed by not less that ONE HUNDRED(1004) per cent of the owners of the Property. Any amendment must be properly recorded.
