DESCRIPTION OF A 4.36 ACRE TRACT OF LAND OUT OF THE A. HARRINGTON LEAGUE, ABSTRACT NO. 55, WASHINGTON COUNTY, TEXAS AND BEING A PORTION OF THE RESIDUE OF A CALLED 10.22 ACRE TRACT OF LAND DESCRIBED IN A DEED DATED JANUARY 1, 1997 FROM ROBERT L. GALL, ET AL TO THE FAMILY TRUST OF ROBERT L. GALL, ET AL, RECORDED IN VOLUME 847, PAGE 619, OF THE OFFICIAL RECORDS OF WASHINGTON COUNTY, TEXAS FOR WHICH REFERENCE IS MADE AND THE SAID 4.36 ACRE TRACT BEING DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

BEGINNING at a 5/8 inch iron rod found (Grid Coordinates: N 10,054,461,28 USft E 3.535,961,33 USft) in the Northwest line of Lounge Road (60' R.O.W.) for the Southeast corner of a called 0.375 acre tract of land described in a deed dated September 25, 1945 from Katherine Ida Dannhaus Gall, et vir to Oscar Krueger, et ux, recorded in Volume 259, Page 484, Washington County Deed Records and being the Southwest corner of the herein described tract:

THENCE North 02° 15' 01" West (called North 01° 12' West) with the Easterly line of said 0.375 acre tract, being the common Westerly line of said residue of 10.22 acre tract a distance of 316.85 feet (called 315.10') to a 5/8 inch iron rod found in the Southerly line of State Highway No. 36 for the Northwest corner of the herein described tract, being the common Northeast corner of said 0.375 acre tract;

THENCE with the Southerly line of State Highway No. 36, being the common Northerly line of said residue of 10.22 acre tract the following:

- North 32° 51' 05" East (called North 36° 55' East) a distance of 242.87 feet to a concrete marker found for corner:
- North 42° 34' 25" East (called North 46° 25' East) a distance of 325.61 feet (called 326.70') to a concrete marker found for corner;
- North 67° 46' 43" East (called North 72° 44' East) a distance of 62.62 feet to a 5/8 inch iron rod found for the Northeast corner of the herein described tract, being the common Northwest corner of a 2.76 acre tract also surveyed on this day, from which a 1/2 inch iron rod found for the Northeast corner of said 2.76 acre tract bears North 67° 46' 43" East a distance of 190.09 feet;

THENCE South 17° 41' 32" East (called South 15° 00' West) across said residue of 10.22 acre tract, being the common Easterly line of the herein described tract at 20.08 feet passing an iron axle found in an interior line of said residue of 10.22 acre tract for the Northwest corner of a called 2.64 acre tract of land described in a deed dated January 1, 1997 from Robert L. Gall, et al to The Family Trust of Robert L. Gall, et al. recorded in Volume 847, Page 620, Washington County Official Records and continuing with the with the Westerly line of said 2.64 acre tract for a total distance of 397.04 feet to a 1/2 inch iron rod found for the Northeast corner of a called 1.000 acre tract of land described in a deed dated March 17, 1976 from Darrel Kruger, et ux to Frankie J. Matura, et ux, recorded in Volume 343, Page 730, Washington County Deed Records, from which a 3/4 inch iron pipe found in the Northwest line of Lounge Road for the Southeast corner of said 1.000 acre tract, being the common Southwest corner of said 2.64 acre tract bears South 17° 48' 04" East. a distance of 228.42 feet;

THENCE South 72° 04' 56" West (called South 75° 00' West) with the Northerly line of said Matura 1.000 acre tract a distance of 188.90 feet (called 190.00') to a 1/2 inch iron pipe found for the Northwest corner of said Matura 1.000 acre tract;

THENCE South 17° 44' 16" East (called South 15° 00' East) with the Westerly line of said Matura 1.000 acre tract a distance of 228.84 feet (called 229.26') to a 1 inch iron pipe found in the Northwest line of Lounge Road for the Southwest corner of said Matura 1.000 acre tract:

THENCE South 72° 11' 35" West (called South 75° West) with the Northwest line of Lounge Road a distance of 48.19 feet to a 5/8 inch iron rod found for the Southeast corner of a called 1.000 acre tract of land described in a deed dated February 28, 2006 from Xtreme Challenge, Inc. to Robert Timothy McCulley, et ux, recorded in Volume 1194, Page 872, Washington County Official Records;

THENCE North 17° 42' 29" West (called North 15° 00' 00" West) with the Easterly line of said McCulley 1.000 acre tract a distance of 239.38 feet (called 239.34') to a 5/8 inch iron rod found for the Northeast corner of said McCulley 1.000 acre tract;

THENCE South 72° 19' 40" West (called South 75° 03' 58" West) with the Northerly line of McCulley 1.000 acre tract a distance of 182.00 feet (called 182.00') to a 5/8 inch iron rod found for the Northwest corner of said McCulley 1.000 acre tract;

THENCE South 17° 42' 41" East (called South 15° 00' 00" East) with the Westerly line of said McCulley 1.000 acre tract a distance of 239.20 feet (called 239.34') to a 5/8 inch iron rod found in the Northwest line of Lounge Road for the Southwest corner of said McCulley 1.000 acre tract;

THENCE South 72° 23' 18" West (called South 75° West) with the Northwest line of Lounge Road a distance of 198.15 feet to the POINT OF BEGINNING, containing 4.36 acres of land, more or less.

Bearing Basis: Texas Lambert Grid, Texas Central Zone, NAD 83/2011 (EPOCH: 2010)

All distances are surface values, to obtain grid values multiply surface distances by a Combined Scale Factor of 0.99997004.
