PROPERTY DESCRIPTION

The subject property is shown on Nottoway County Tax Map records as parcel number # 41-124. According to the tax records the property contains 294.5 acres. The deed is recorded in Deed Book 455 on Page 820. A review of the Nottoway County Tax Records indicates the following:

The subject property is currently zoned Conservation (C-1) and is located within Nottoway County's development zone. This zoning requires road frontage and allows for private interior roads built to state specifications. The minimum lots size permissible is 2 acre with a minimum of 200 feet of width at the setback. The county planners require a Length-to-Width Ratio of 5.5-to-1.

It has long frontage on the Little Nottoway River. A tributary of that river meanders through the tract too. In all, approximately 46 acres +/- of the subject property is found in riverine lowgrounds/wetlands. There is about 8.25 Acres +/- of land found in the high-voltage powerline easement crossing the tract. The network of interior roads and small open areas/food plots cover about 11 acres +/-.

The forest resources on the subject property are estimated below based on historical aerial photos, etc.:

- 1) 117 Acres +/- of Thinned (~2007) Loblolly pines established around 1987 to 1989;
- 2) 48 Acres +/- of Unthinned Loblolly pines established around 1987 to 1989;
- 3) 36 Acres +/- of Thinned (~2007) Loblolly pines established around 1992 to 1993; and
- 4) 28 Acres +/- Of Natural Mixed Hardwoods in the Streamside Management Zones (SMZs).

Per the county tax maps, the subject property has about 400 feet +/- of road frontage on The Grove Road (State Route 603).

The subject property is located on the southside of Old Highway 460 on The Grove Road. It is located 3 miles northwest of the Town of Blackstone. It's located centrally between Nottoway Courthouse and Blackstone.










