A parcel of land located on a part of Government Meandered Lots Three (3) and Four (4) of Section Six (6), Township Twenty-eight (28) North of Range Twelve (12) West; Commencing at the 1/4 Section corner of the North Line of Section Six (6); thence West on the North line of Section Six (6) Township Twenty-eight (28) North of Range Twelve (12) West, 929 feet; thence South 4½ degrees West 327 feet; thence South 21 degrees West 541 feet; thence South 1½ degrees West 400 feet to the place of beginning; thence 90 degrees West 190 feet to the low water mark of the Red Cedar River; thence Southerly along the low water mark of the Red Cedar River 92 feet; thence 90 degrees East 197 feet; thence North 1½ degrees East 93 feet. 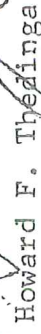
