Curry Survey, Abstract No. 257, McLennan County, Texas, and being out of and a part of that certain called 7.4 acre tract of land described to Linda Mynarcik, recorded in Volume 294, Page 128 of the Official Public Records of McLennan County, Texas and being out of and a part of that certain called 3.058 acre tract of land described to Linda Mynarcik, recorded in Volume 294, Page 128 of the Official Public Records of McLennan County, Texas, said 9.92 acres being more particularly described by metes and bounds as follows;

BEGINNING at a 1/2 inch iron rod with yellow cap set at a pipe fence corner post at the southwest corner of the above mentioned 7.4 acre tract, same being the northwest corner of that certain called 26.08 acre tract to Joyce Hartford, (101/445 O.P.R.), located on the east line of Old Dallas Road, for the southwest corner of this:

THENCE along the west line of said 7.4 acre tract, common boundary with said road and along a fence line, N 03°50'15" W a distance of 1083.57 feet to a 1/2 inch iron rod with yellow cap set for the northwest corner of this;

THENCE crossing said 7.4 acre tract, and the above mentioned 3.058 acre tract N 52°43'16" E a distance of 319.31 feet to a 1/2 inch iron rod iron rod with yellow cap set on the east line of said 3.058 acre tract, located on the east line of that certain 18.204 acre tract to Richard Maddox, (doc. #2005027034), for the northeast corner of this;

THENCE along the east line of said 3.058 acre tract, common boundary with said 18.204 acre tract, S 14°36'56" E a distance of 890.55 feet to a pipe fence corner post at the south corner of said 3.058 acre tract, located on the east line of said 7.4 acre tract, being the west corner of a 5.0 acre tract to Theresa Gibbs, for an angle point of this;

THENCE along the east line of said 7.4 acre tract, common boundary with said 5.0 acre tract, S 33°25'57" E a distance of 234.61 feet to a 1/2 inch iron rod found at a fence corner at the southeast corner of said 7.4 acre tract, being the northeast corner of said 26.08 acre tract, for the southeast corner of this;

THENCE along the south line of said 7.4 acre tract, common boundary with said 26.08 acre tract, S 67°56'23" W a distance of 577.82 feet to the **POINT OF BEGINNING**, in all containing **9.92** acres of land.

BEGINNING at a 1/2 inch iron rod with yellow cap set at a fence corner post at the north corner of the above mentioned 7.4 acre tract, same being the northwest corner the above mentioned 3.058 acre tract, also being the southwest corner of that certain called 1.4 acre tract to H. L. Vavra, et al, (doc. #2010017913), located on the east line of Old Dallas Road, for the northwest corner of this;

THENCE along the north line of said 3.058 acre tract, common boundary with said 1.4 acre tract and along a fence line, N 52°44'13" E a distance of 309.53 feet to a 1/2 inch iron rod with yellow cap set at a fence corner post at the northeast corner of said 3.058 acre tract, same being the southeast corner of said 1.4 acre tract, and the northwest corner of that certain called 18.204 acre tract, (doc. #2005027034), for the northeast corner of this;
