



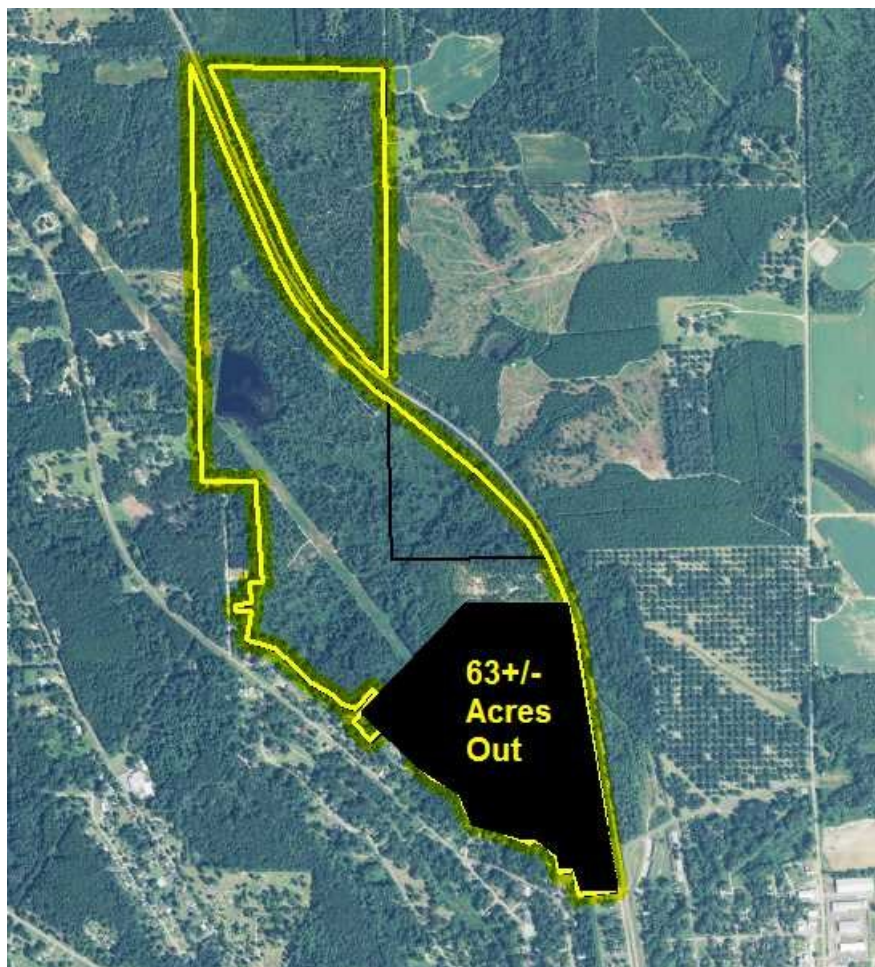

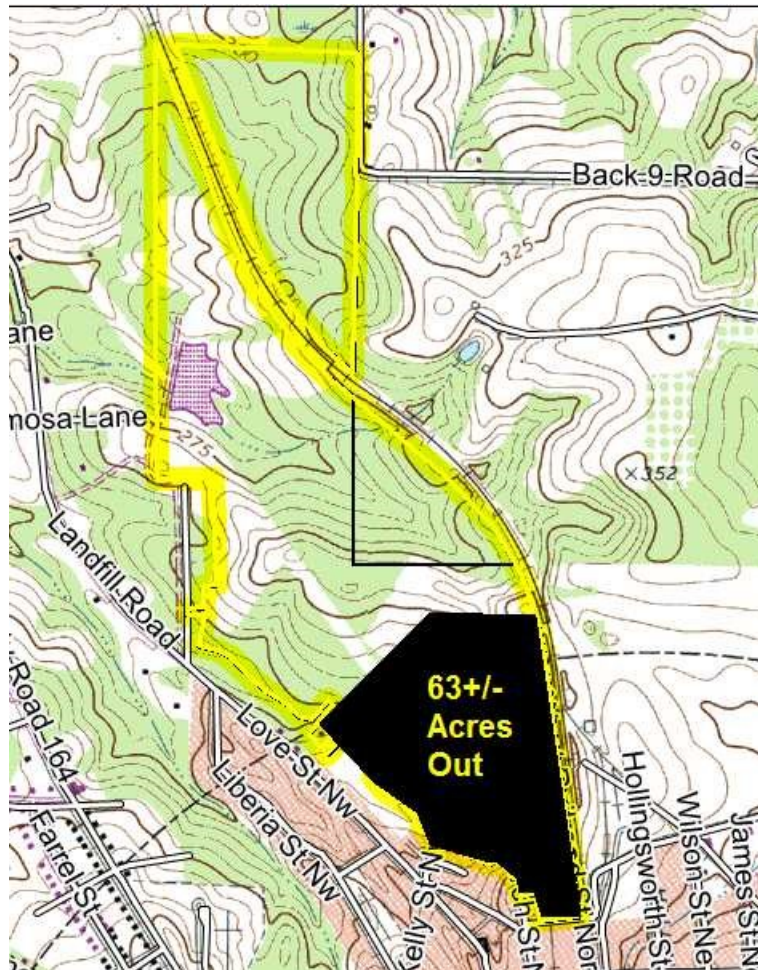


2011 Landcroc Flown Map



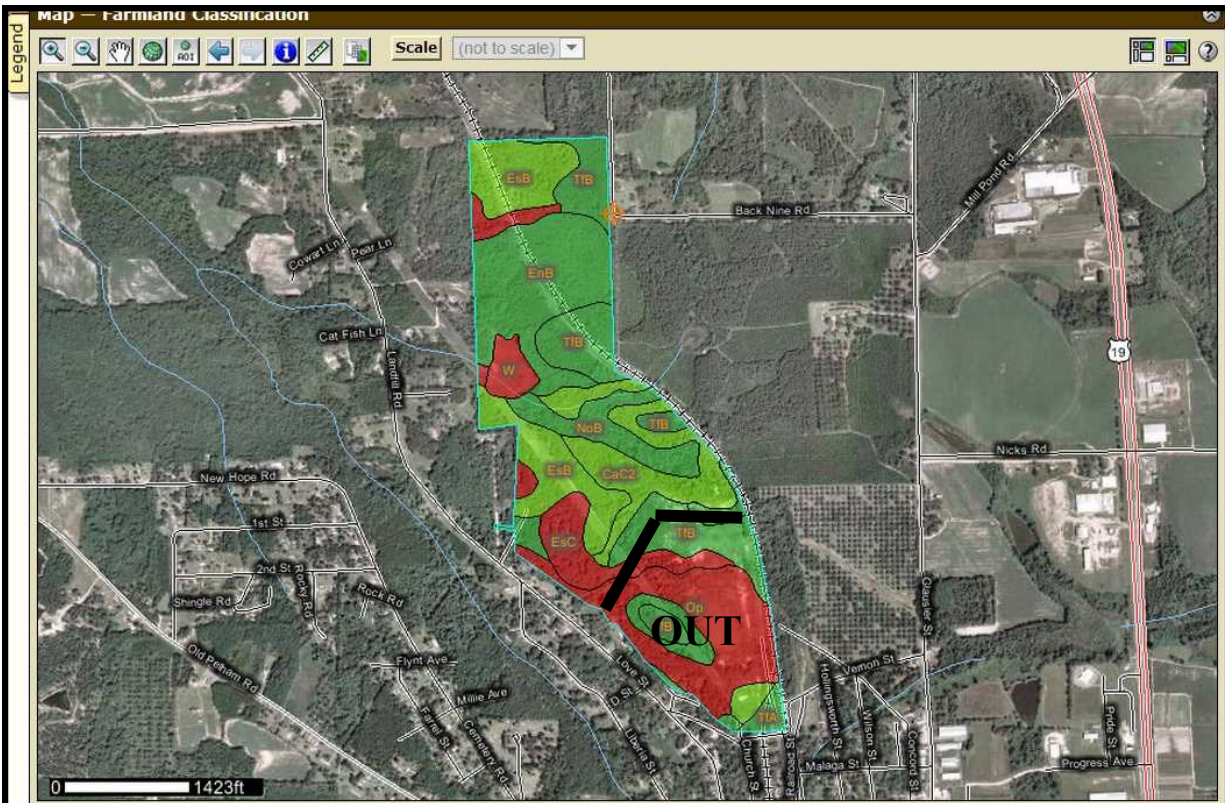
