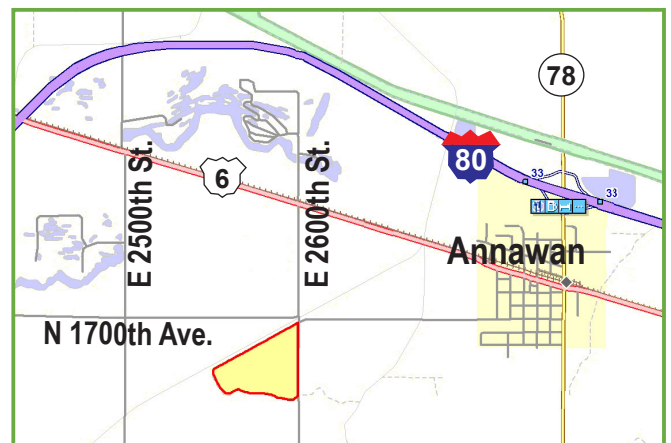
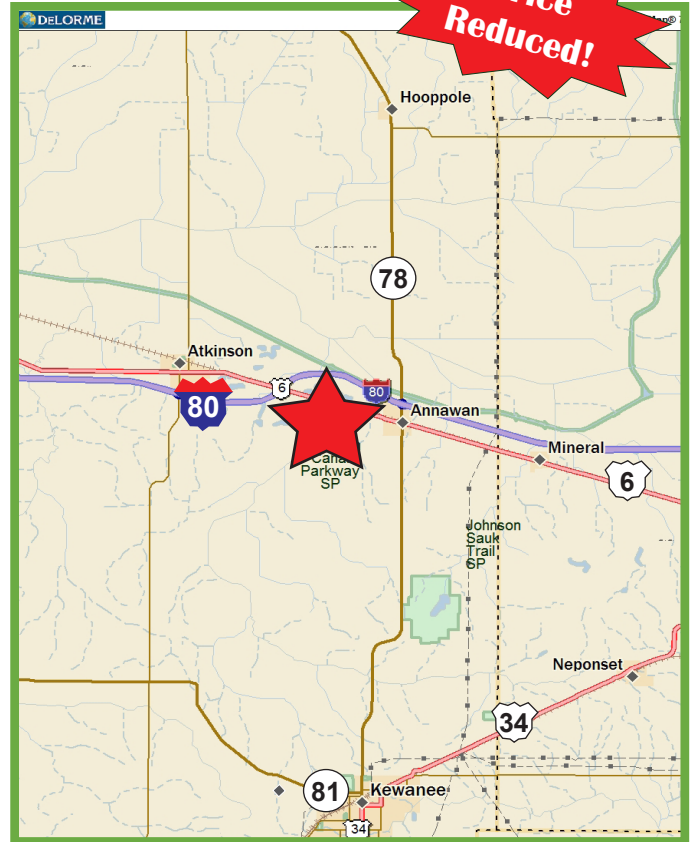

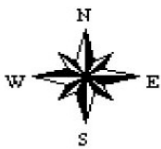

Aerial Photo & Soils Map



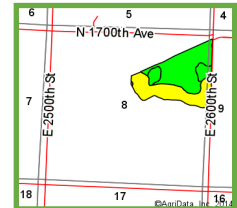
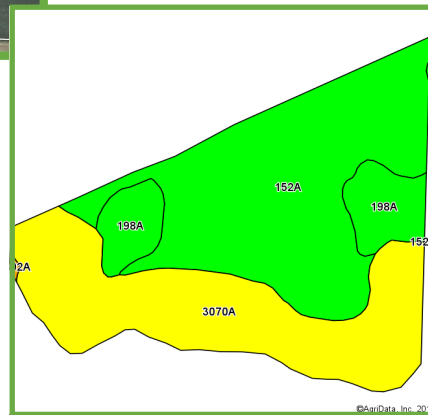
