Dickerson 132.67 acre tract described in Volume 1195, Page 342 of said official records;

**THENCE:** S 89º 20' E 1326.12 Ft., with the common line between said Lewis and Moore Surveys and the south lines of said Dickerson 132.67 acres and Schulze 42.57 acres, to the **PLACE OF BEGINNING AND CONTAINING WITHIN THESE BOUNDS 31.258 ACRES OF LAND.**


