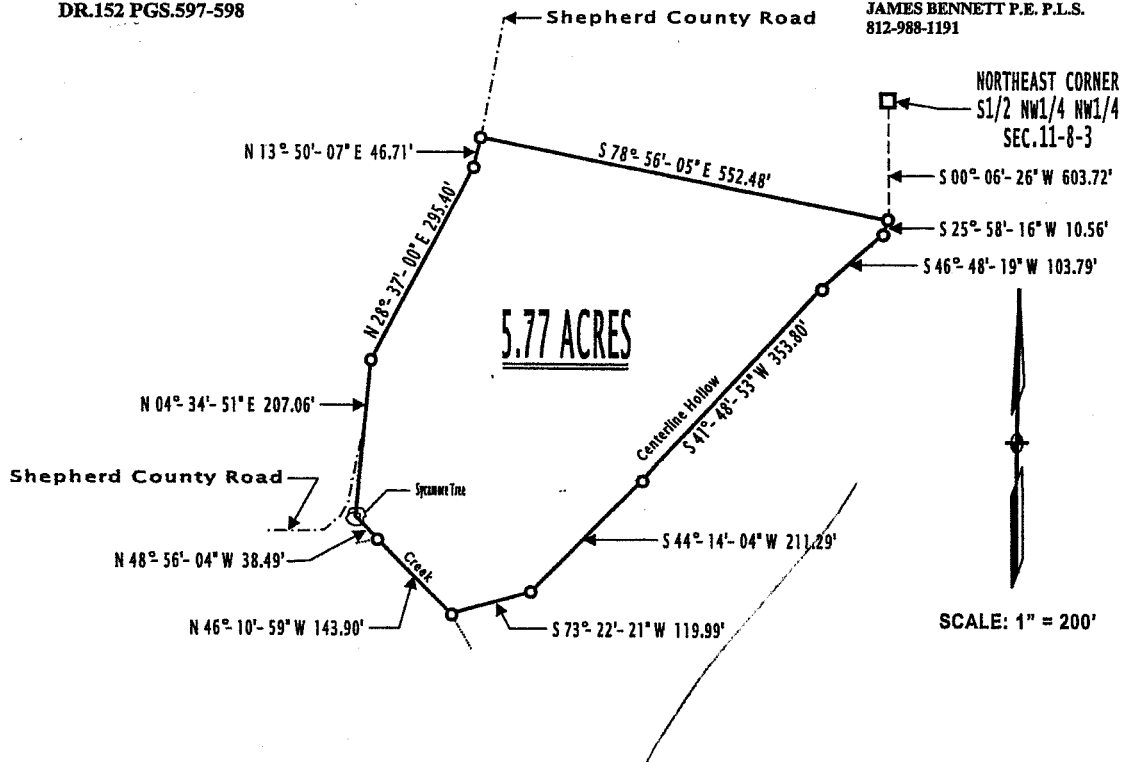

PART OF THE WEST HALF OF THE NORTHWEST QUARTER OF SECTION 11, TOWNSHIP 8 NORTH,
RANGE 3 EAST OF THE SECOND PRINCIPAL MERIDIAN, VAN BUREN TOWNSHIP, BROWN COUNTY,
INDIANA DESCRIBED AS FOLLOWS:

COMMENCING AT THE NORTHEAST CORNER OF THE SOUTH HALF OF THE NORTHWEST
QUARTER OF THE NORTHWEST QUARTER OF SAID SECTION 11; THENCE SOUTH 00 DEGREES 06
MINUTES 26 SECONDS WEST ON AND ALONG THE EAST LINE OF SAID SOUTH HALF, NORTHWEST
QUARTER, NORTHWEST QUARTER 603.72 FEET TO THE CENTER OF A HOLLOW AND THE
BEGINNING; THENCE THE FOLLOWING FIVE (5) COURSES ARE WITH THE CENTER OF SAID
HOLLOW: SOUTH 25 DEGREES 58 MINUTES 16 SECONDS WEST 10.56 FEET, SOUTH 46 DEGREES 48
MINUTES 19 SECONDS WEST 103.79 FEET, SOUTH 41 DEGREES 48 MINUTES 53 SECONDS WEST
353.80 FEET, SOUTH 44 DEGREES 14 MINUTES 04 SECONDS WEST 211.29 FEET AND SOUTH 73
DEGREES 22 MINUTES 21 SECONDS WEST 119.99 FEET TO A CREEK; THENCE NORTH 46 DEGREES
10 MINUTES 59 SECONDS WEST WITH SAID CREEK 143.90 FEET; THENCE LEAVING SAID CREEK
NORTH 48 DEGREES 56 MINUTES 04 SECONDS WEST 38.49 FEET; THENCE NORTH 04 DEGREES 34
MINUTES 51 SECONDS EAST 207.06 FEET TO SHEPHERD COUNTY ROAD; THENCE THE FOLLOWING
TWO (2) COURSES ARE WITH SAID COUNTY ROAD: NORTH 28 DEGREES 37 MINUTES 00 SECONDS
EAST 295.40 FEET AND NORTH 13 DEGREES 50 MINUTES 07 SECONDS EAST 46.71 FEET; THENCE
LEAVING SAID COUNTY ROAD SOUTH 78 DEGREES 56 MINUTES 05 SECONDS EAST 552.48 FEET TO
THE BEGINNING, CONTAINING 5.77 ACRES MORE OR LESS.
