**METHOD OF SALE:** Halderman Real Estate Services, Inc. (HRES, IN Auct. Lic. #AC69200019) will offer this property at public auction on March 18, 2014. At 6:30 PM, 98 acres, more or less, will be sold at the Golay Community Center, Cambridge City, IN. This property will be offered as one single unit, in tracts or in combination. Each bid shall constitute an offer to purchase and the final bid, if accepted by the Sellers, shall constitute a binding contract between the Buyer(s) and the Sellers. The auctioneer will settle any disputes as to bids and his decision will be final. **ACREAGE:** The acreages listed in this brochure are estimates taken from the county assessor's records, FSA records and/or aerial photos.

**SURVEY:** The Sellers reserve the right to determine the need for and type of survey provided. If an existing legal description is adequate for title insurance for a tract or tracts, no new survey will be completed. If the existing legal description is not sufficient to obtain title insurance, or if this property sells in multiple tracts requiring new legal descriptions, a survey will be completed, the cost of which will be shared 50/50 by the Sellers and the Buyer(s). The Sellers will choose the type of survey to be completed and warrant that it will be sufficient to provide an owner's title insurance policy for the tract(s). If a survey is completed, the purchase price for the surveyed tract(s) will be adjusted, up or down, to the exact surveyed acres. The price per acre will be the auction bid price for the tract, divided by the tract acreage estimated in the auction brochure. Combination purchases will receive a perimeter survey only.

**SURVEY NOTE:** If a survey is needed, final tract specifications will be adjusted to Wayne County Planning & Zoning & Building Commission requirements.

**DOWN PAYMENT:** 10% of the accepted bid down on the day of the auction with the balance due at closing. The down payment must be in the form of personal check, cashier's check, cash or corporate check. **YOUR BIDDING IS NOT CONTINGENT UPON FINANCING. BE SURE YOU HAVE FINANCING ARRANGED, IF NECESSARY, AND ARE CAPABLE OF PAYING CASH AT CLOSING.**

**BUYER'S PREMIUM:** A Buyer's Premium of 1% will be added to the total of each successful bid.

**APPROVAL OF BIDS:** The Sellers reserve the right to accept or reject any and all bids. All successful bidders must enter into a purchase agreement the day of the auction, immediately following the conclusion of the bidding.

**DEED:** The Sellers will provide a General Warranty Deed at closing.

**EVIDENCE OF TITLE:** The Sellers will provide an Owner's Title Insurance Policy to the Buyer(s). Each Buyer is responsible for a Lender's Policy, if needed. If the title is not marketable, then the purchase agreement(s) are null and void prior to the closing, and the Broker will return the Buyer's earnest money.

**EASEMENTS:** The sale of this property is subject to any and all easements of record.

**EASEMENT - TRACTS 2 & 3:** If Tracts 2 & 3 sell separately, the Buyer(s) of Tract 2 will grant a non-exclusive, ingress and egress easement for the benefit of the Buyer(s) of Tract 3, allowing access to the building on Tract 3. If an easement is granted, the costs for maintaining the drive over the easement will be shared 50-50.

**CLOSING:** The closing shall be on or about April 23, 2014. The Sellers have the choice to extend this date if necessary.

**POSSESSION:** Possession of land will be at closing or can be earlier with an additional earnest money deposit. Possession of buildings will be 30 days after closing.

**REAL ESTATE TAXES:** Real estate taxes are \$2,245.24. The Sellers will pay the 2013 taxes due and payable in 2014. The Buyer(s) will pay the 2014 taxes due and payable 2015 and all taxes thereafter.

**MINERAL RIGHTS:** All mineral rights owned by the Sellers will be conveyed to the Buyer(s).
