SAID TRACT BEING MORE PARTICULALRY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

COMMENCING at a fence corner found at the point of intersection of the North R.O.W. of County Road 213 and the East R.O.W. of County Road 213 being the Southwest corner of said 557.047 acre tract, the Southwest corner of this tract and the POINT OF COMMENCMENT.

- With said curve to the left, radius = 2836.50 feet, arc = 463.33 feet, and a chord that bears N 11° 55' 07" W, 462.81 feet to a ½" iron rod set for the Northwest corner of this tract.
