The subject property is currently zoned Agricultural (A-1). There are approximately 1,750 feet of frontage on the northside of Highway 58 (Southampton Parkway).


Three Creek meanders near the northern boundary of the subject property. A Norfolk and Southern railway line dissects the property.









FOREST TYPE MAP




