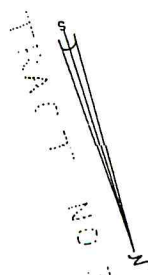

1 The drainage of arable lands into roads, streets, rivers or public ditches, either directly or indirectly, is strictly prohibited.

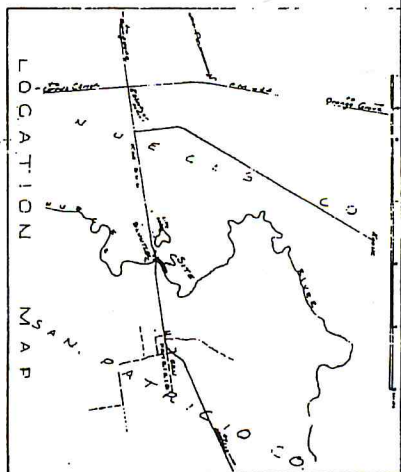
