Back Wall

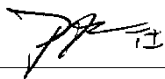
The north brick-wall, exterior to the living room had several minor cracks in the mortar effecting 9 bricks and approximately 13 feet of mortar. The repaired wall is has outward displacement from of 0 inches at it's most minimally effected place to 5/16 of an inch displacement at it's maximum point. While we are uncertain as to the movements origin, we are confident that the dual approach of foundation support (Installed lifetime warrantied piers by MBR Foundation and wholly new roof in 2012) minimizes most sources for future movement.

Wood Rot

At several points on the roof facea and roof decking edge, water caused minor wood rot. All facea and decking wood damage replaced at time new roof put on in August of 2012.

Termites

In 2002 the previous owner had the home treated for termites. We purchased in 2006 and have found no evidence of termite damage in or around the home. We currently protect the home with an IsopThor termite interceptor and disposal system, (21 station) which utilizes the latest technology for early detection and bio-chemical intervention of termites, thus preventing or inhibiting infestations.
