## RESTRICTIONS BCH

KNOW ALL MEN BY THESE PRESENTS that JAMES Q. WRAY and wife, MARY C. WRAY of Union County, North Carolina, do hereby covenant and agree to and with all persons, firms or corporations hereinafter acquiring any of the property below described:

BEING all of Lots one (1) through nineteen (19) of Valhalla Farms, Section Two, as per plat and survey of Edward L. Killough, N.C.R.L.S., dated January 17, 1978, and recorded in Map Cabinet A, page 118-A in the office of the Register of Deeds of Union County, North Carolina.

That said property is hereby made subject to the following restrictive and protective covenants as to the use thereof, running with the land, by whomsoever owned, to wit:

- 1. No structure shall be erected, altered, placed or permitted on any lot other than one detached single-family dwelling. No structure erected on said premises shall be designated for use and occupancy by more than one family. Guest houses shall be permitted upon the premises, but said guest houses shall not be regularly rented as an apartment or apartment house.
- 2. No house shall be erected upon any of said lots nearer to the street than one hundred (100) feet from the front line and no house shall be erected on any of said lots nearer than fifty (50) feet from any side lot line, except a detached garage, or guest house located adjacent to a residential dwelling house and said detached building shall not be nearer than thirty (30) feet to any said lot line.
- 3. No lot shall be subdivided unless each lot created by the subdivision is a minimum of two and one-half (2 1/2) acre.
- 4. The enclosed and heated living area of the main structure, exclusive of open porches, garages, basements, and other unheated spaces, shall not be less than two thousand (2,000) square feet for a one-story type building, nor less than twelve hundred (1,200) square feet contained in the ground-level floor of a two-story type building
