All that certain tract or parcel of land, situated in the County of Franklin, State of Texas, being in the Titus Starnes Survey, Abstract No. 438, and the James E. Hopkins Survey, Abstract No. 217, and being all that certain 24.356 acre tract described in a Deed from Lonnie Dale Lowder to Raefel E. Shields, et ux, Nancy J., recorded in Volume 235, Page 149, Real Property Records of said County, and bounded as follows:

Beginning at typical steel rod (typical steel rod is a ½ inch by 24 inch rebar with surveyors cap marked "Noble") set on the SEC of said 24.356 acre tract, same being the NEC of a 13.392 acre tract described in a Deed from Paul Elmo Caton, et ux, to Gregg Mayes, et ux, recorded in Volume 235, Page 732, Deed Records, and being on the West right-of-way line of F. M. Highway No. 2723;

THENCE North 89° 59' 26" West at 7.95 feet passing a 1 inch iron pipe found for reference and continuing generally along the fenced SBL of said 24.356 acre tract and the NBL of said 13.392 acre tract a total distance of 890.85 feet to a 40d nail found on the SWC of said 24.356 acre tract and being on the EBL of a 60.453 acre tract described in a Deed from Robert Hall Swain, et ux, to Glenn Gurley, et ux, recorded in Volume 250, Page 555, Deed Records;

THENCE North 00° 00' 00" East generally along the fenced WBL of said 24.356 acre tract and the EBL of said 60.453 acre tract, 1325.73 feet to a crimped ½ inch iron pipe found on the NWC of said 24.356 acre tract, same being the NEC of said 60.453 acre tract, and being on the SBL of the Tres Lagos Subdivision, recorded in Volume H, Page 173, Surveyors Records;

THENCE South 88° 54' 22" East generally along the fenced NBL of said 24.356 acre tract and the SBL of said Tres Lagos Subdivision, at 623.86 feet passing a 1 inch iron pipe found for reference and continuing a total distance of 633.88 feet to a typical steel rod set on the NEC of said 24.356 acre tract, and being on the West right-of-way line of said F. M. Highway No. 2723, a concrete right-of-way marker bears North 05° 18' 26" West – 174.88 feet;

THENCE with the West right-of-way line of said F. M. Highway No. 2723 as follows: with a curve to the left having a chord bearing of South 19° 39' 10" East - 116.04 feet, a radius of 602.96 feet, and an arc length of 116.22 feet to a point for an angle corner;

THENCE South 26° 05' 02" East along the West right-of-way line of said F. M. Highway No. 2723, 90.11 feet to a point for an angle corner;

THENCE along the West right-of-way line of said F. M. Highway No. 2723 with a curve to the right having a chord bearing of South 17° 29' 50" East - 219.23 feet, a radius of 851.47 feet, and an arc length of 219.84 feet to a point for an angle corner;
