METES AND BOUNDS DESCRIPTION OF

A 12.441 acre tract of land situated in the B. S. & F. Railroad Survey No. 3, Abstract 74, in Kerr County, Texas and being a part of the unrecorded subdivision of B, and R. Ranch, Inc. Property. Said 12.441 acres being the occupied land of that deed recorded in volume 1253, page 563, Real Property Records of Kerr County, Texas, and being more particularly described as follows:

BEGINNING at a wood fence post on the north Roadway line of Stoneleigh Rd., 25.00' north of

a P.K. nail found in asphalt road at the common corner of Lot 212, Lot 212-A, Lot 213 of said B. And R. Ranch Subdivision and the southwest corner of the herein

described tract;

THENCE North 00° 30' 00" East a distance of 974.77 feet along the east line of said Lot

212-A with a fence to a wood fence post found at the northwest corner of the

herein described tract;

THENCE South 89° 57' 58" East a distance of 410.95 feet along the south line of Lot 218-A

of said B. And R. Ranch Subdivision, with a fence to a metal fence post found on

the west right-of-way line of Stoneleigh Rd. (A 50' wide R.O.W.);

THENCE Along the westerly right-of-way line of Stoneleigh Rd. and with a fence the

following courses and distances:

South 29° 32' 00" East a distance of 418.94 feet to a wood fence post;

South 09* 48' 09" East a distance of 55.97 feet to a wood fence post;

South 00° 56' 32" East a distance of 71.56 feet to a gate post found on the line of

said deed recorded in volume 1253, page 563;

South 22* 17' 49" West a distance of 20.39 feet to a gate post; South 05* 49' 17" West a distance of 214.71 feet to a wood fence post; South 33° 55' 56" West a distance of 274.70 feet to a wood fence post; South 62° 51' 52" West a distance of 55.30 feet along the northwest line of a county right-of-way deed recorded in volume 921, page 161, Real property

Records, to a wood fence post;

North 89° 40' 07" West a distance of 404.60 feet along the north right-of-way line THENCE

of Stoneleigh Rd. to the Point-of-Beginning, containing 12.441 acres of land.

The bearings are based on the deed recorded in volume 1253, page 563, Real Property Records, Kerr County, Texas.
