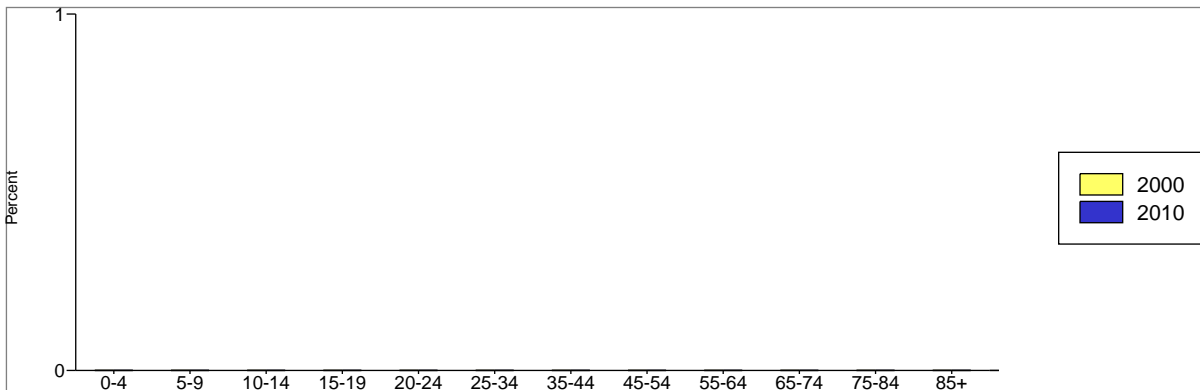

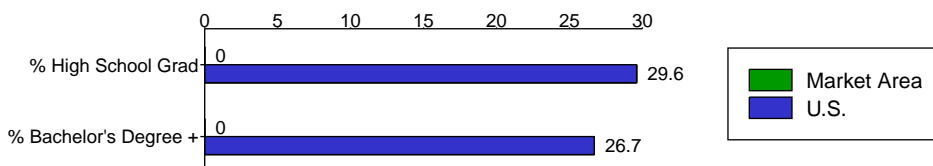

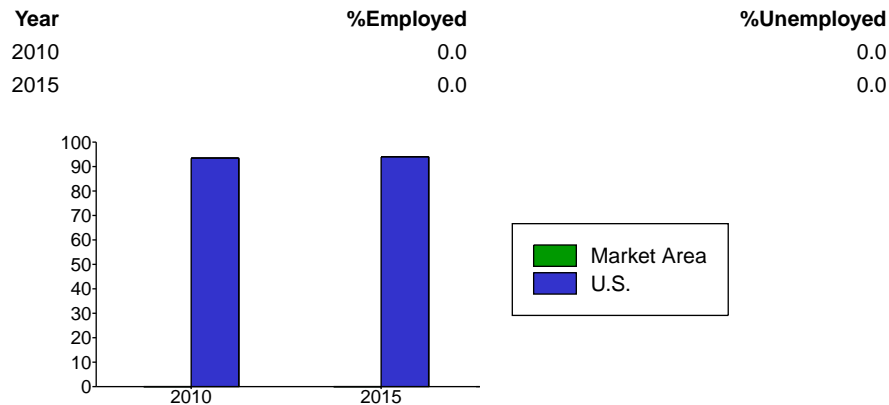

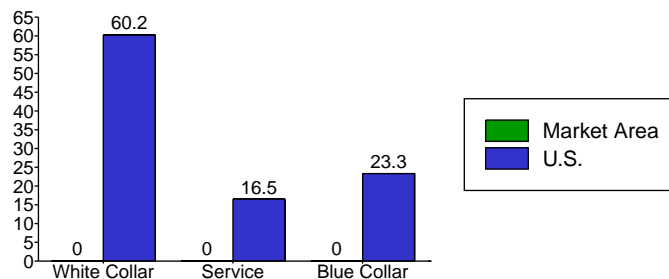

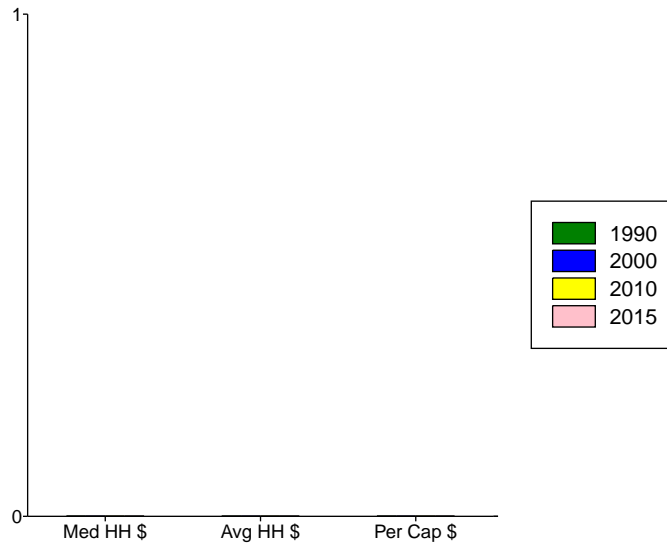

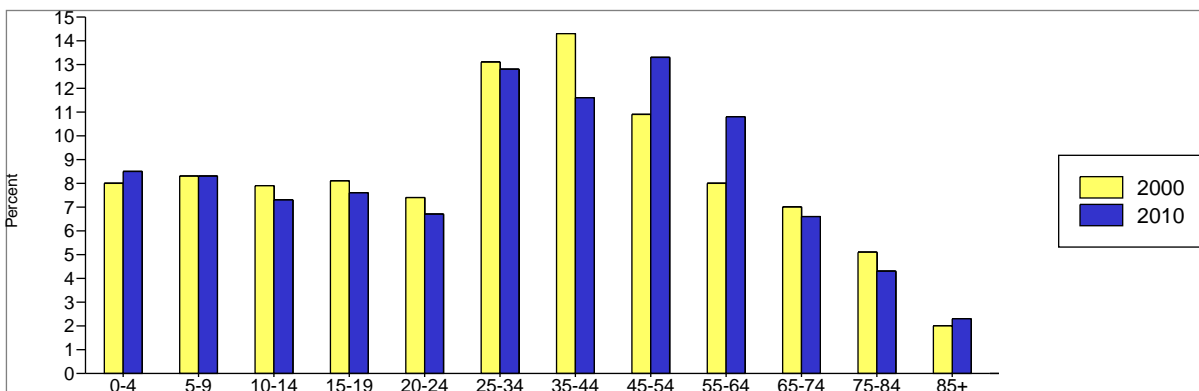

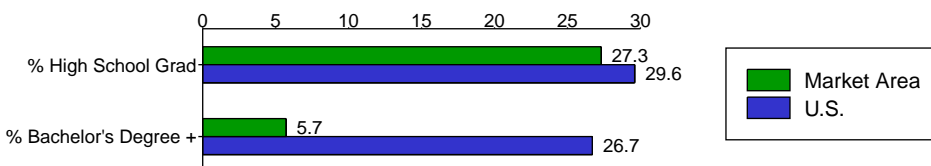

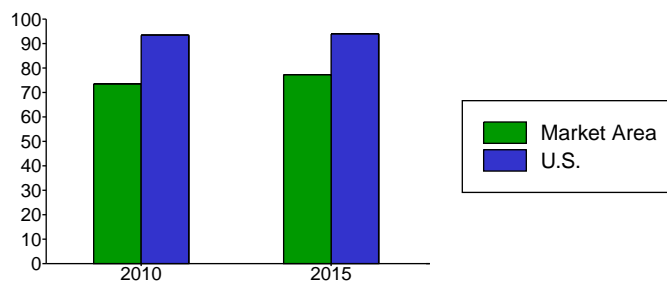

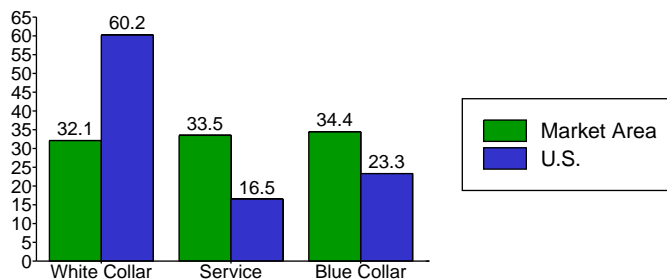

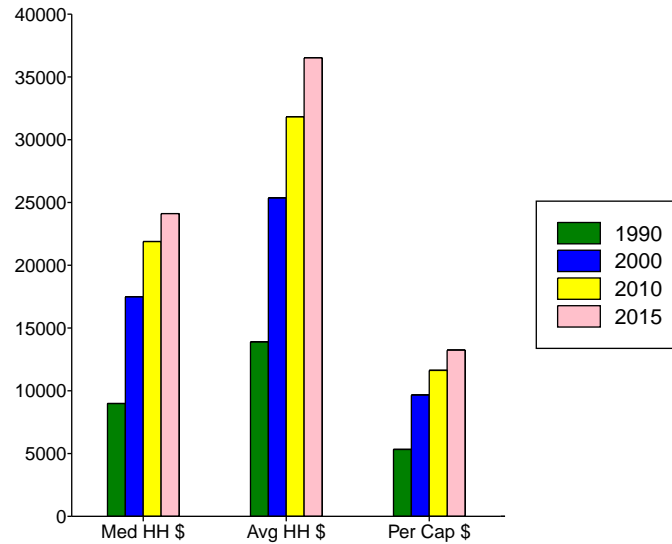

Housing

Currently, 28.4 percent of the 2,804 housing units in the market area are owner occupied; 48.9 percent, renter occupied; and 22.7 percent are vacant. In 2000, there were 2,691 housing units- 30.4 percent owner occupied, 51.2 percent renter occupied and 18.4 percent vacant. The annual rate of change in housing units since 2000 is 0.4 percent. Median home value in the market area is \$50,676, compared to a median home value of \$157,913 for the U.S. In five years, median home value is projected to change by 1.63 percent annually to \$54,956. From 2000 to the current year, median home value changed by 1.81 percent annually.

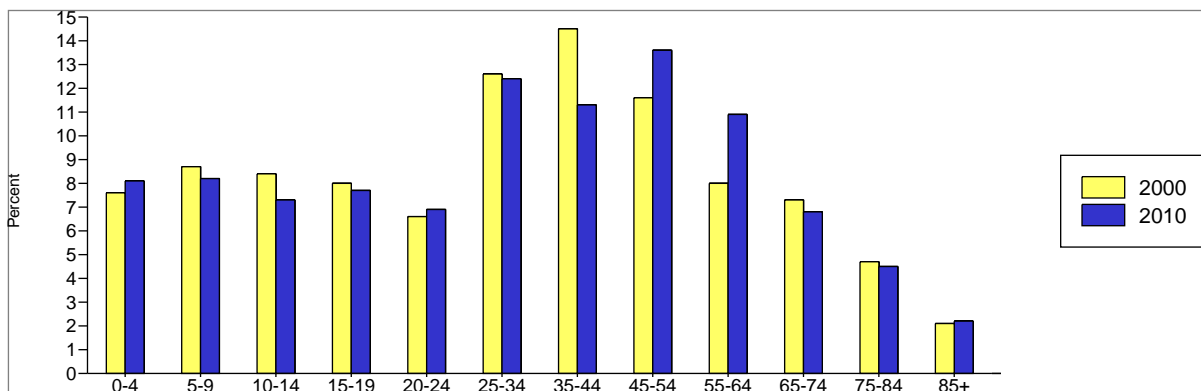

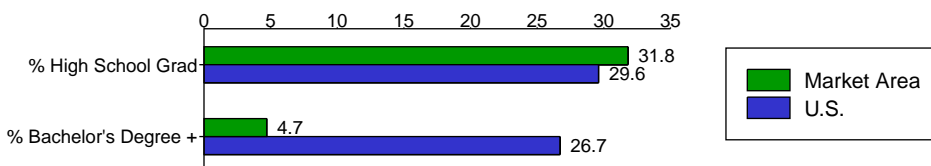

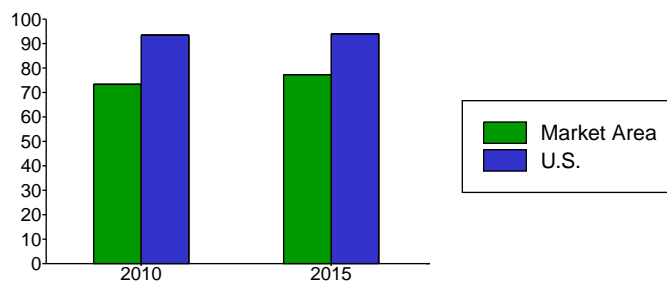

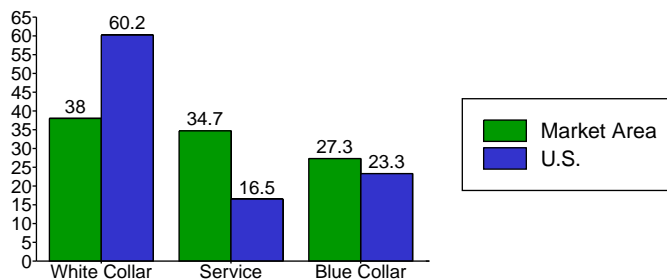

Housing

Currently, 31.7 percent of the 11,685 housing units in the market area are owner occupied; 50.7 percent, renter occupied; and 17.7 percent are vacant. In 2000, there were 10,925 housing units- 34.0 percent owner occupied, 52.6 percent renter occupied and 13.4 percent vacant. The annual rate of change in housing units since 2000 is 0.66 percent. Median home value in the market area is \$45,586, compared to a median home value of \$157,913 for the U.S. In five years, median home value is projected to change by 1.98 percent annually to \$50,278. From 2000 to the current year, median home value changed by 1.82 percent annually.
