

EXHIBIT "B" LEGAL DESCRIPTION OF 0.51 AC. OF LAND TO **ACCOMPANY PLAT OF SAME**

All that certain lot, tract, or parcel of land situated in Ellis County, Texas, being 0.51 acres of land, a part of the SAMUEL HERBOUGH SURVEY, A-477, and being that certain tract as described in a deed as recorded in Vol. 538, Page 217 in Deed Records of said Ellis County, this 0.51 ac. tract being more particularly described as follows:

Beginning at a 5/8" Iron Rod found for the northeast corner of said tract in Vol. 538, Page 217 (this Deed grants the 30' alley that was created by Deed in Vol. 197, Page 386) in Deed Records, being a point in the westerly right of way line of West Crossmain (also known as Milford-Itasca Road, 50.0' R/W);

Thence South 30 deg. 00 min. 00 sec. East along the southwesterly right of way line of said West Crossmain a distance of 109.91 ft. to a found 5/8" Iron Rod for the southeast corner of this 0.51 Acre tract;

Thence South 58 deg. 28 min. 52 sec. West (Record is South 60 deg 00 min West) a distance of 202.01 ft. to a point in the easterly line of an alley (50'), being a 5/8" Iron Rod found for the southwest corner of this tract;

Thence North 30 deg. 02 min. 41 sec. West (Record is North 30 deg 00 min West) along said easterly line of an alley a distance of 109.44 it. to a 1" Iron pipe found for the northwest corner of this tract and southwest corner of a tract as described in Vol. 107, Page 53 of Ellis County Deed Records;

Thence North 58 deg. 28 min. 34 sec. East (Record is North 60 deg 00 min East) along the northerly line of this 0.51 acre tract and southerly line of said tract in Vol. 107, Page 53 of Ellis County Deed Records, a distance of 202,10 ft. to THE POINT OF BEGINNING and containing an area of 0.51 acres more or less.

THIS TRACT IS SUBJECT TO, HOWEVER, THE FOLLOWING **EASEMENT AND/OR RESERVATION:**

1.) An easement for an electrical transmission line that is shown as being in Vol. 388, Page 214 in a deed recorded in Vol. 1585, Page 459. However, that is not the correct location for the easement, and the transmission line as it is actually located on the ground is shown on Exhibit "A".
