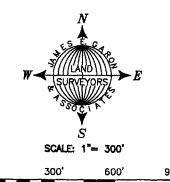
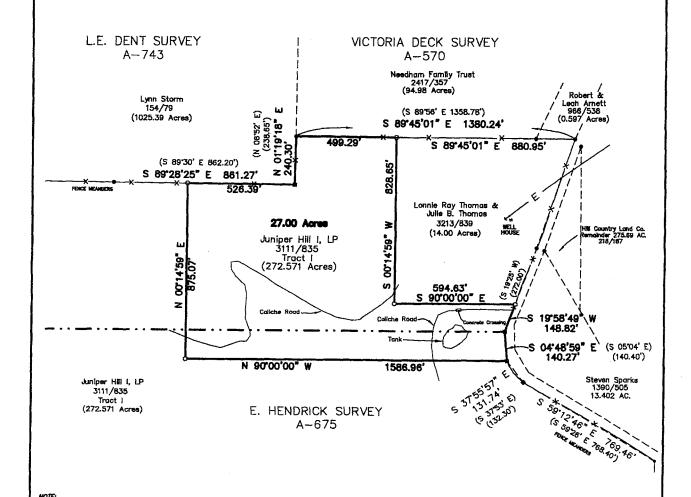

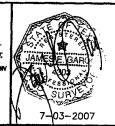

**BEGINNING** at a 3/8" iron rod set in the westerly line of Mt. Olive Road, the easterly line of said 272.571 acre tract for the easterly northeast corner hereof, being the southeast corner of that certain 14.00 acre tract of land conveyed to Lonnie Ray and Julie B. Thomas by deed recorded in Volume 3213, Page 357 of the Official Public Records of Hays County, Texas.

THENCE, with the westerly line of Mt. Olive Road for the easterly line of said 272.517 acre tract and hereof S 19°58'49" W a distance of 148.82 feet to a fence corner post found for an angle point and S 04°48'59" E a distance of 140.27 feet to a fence corner post found for the southeasterly corner hereof;

THENCE N 90°00'00" W a distance of 1586.96 feet for the southerly line hereof to an iron rod set for the southwesterly corner hereof;

THENCE N 00°14'59" E a distance of 875.07 feet for the westerly line hereof to an iron rod set in the southerly line of that certain 1025.39 acre tract of land conveyed to Lynn Storm by deed recorded in volume 154, page 79 of the Deed Records of Hays County, Texas, the northerly line of said 272.517 acre tract for the northwesterly corner hereof;

THENCE for the northerly line hereof the following three (3) calls:

- 1) S 89°28'25" E a distance of 526.39 feet with the southerly line of said Storm tract, to a fence corner post found for an ell corner hereof.
- 2) N 01°19'18" E a distance of 240.30 feet with the easterly line of said Storm tract to an iron rod found at the southwesterly corner of that certain 94.98 acre tract of land conveyed to the Needham Family Trust by deed recorded in Volume 2417, Page 357 of the Official Public Records of Hays County, Texas for an ell corner hereof.
- 3) S 89°45'01" E a distance of 499.29 feet to an iron rod set at the northwest corner of said Thomas tract for the most northerly northeast corner hereof;
