THENCE South 83 degrees 12 minutes 21 seconds East, a distance of 1,371.30 feet to a 5/8" iron rod found for the northeast corner of herein described tract;

THENCE South 18 degrees 01 minutes 58 seconds West, a distance of 1,230.46 feet to a 5/8" iron rod found for an angle point of herein described tract;

THENCE South 01 degrees 29 minutes 26 seconds West, a distance of 708.93 feet to a 5/8" iron rod found in the centerline of Starview Lane for the southeast corner of herein described tract;

THENCE South 57 degrees 30 minutes 02 seconds West, with the centerline of Starview Lane, a distance of 140.55 feet to a 1/2" iron rod found for an angle point of herein described tract;

THENCE South 85 degrees 13 minutes 58 seconds West, continuing along the centerline of Starview Lane, a distance of 107.03 feet to a point for an angle point of herein described tract;

THENCE North 83 degrees 29 minutes 56 seconds West, continuing along the centerline of Starview Lane, a distance of 807.48 feet to a point for an angle point of herein described tract;

THENCE North 85 degrees 47 minutes 35 seconds West, continuing along the centerline of Starview Lane, a distance of 174.87 feet to a point for the southwest corner of herein described tract from which a 1/2" iron rod found for reference bears North 06 degrees 45 minutes 35 seconds East, 21.42 feet;


