





Posey Place Tract Listing #4628 - 80± Acres

The Posey Place Tract (Listing #4628) is located one-half (½) mile northwest of Whelen Springs. The tract is described as W½ of NW¼, Section 27, Township 10 South, Range 20 West, containing 80 acres, more or less, Clark County, Arkansas. Timber primarily consists of approximately 68 acres of pine sawtimber and regeneration plus 12 acres of a 2013 pine plantation north of Highway 51. Access is frontage on State Highway 51. Terrain is gently rolling.
