PROTECTIVE COVENANTS

THE FOLLOWING PROTECTIVE COVENANTS ARE COVENANTS RUNNING WITH THE LAND

- 1. NO STRUCTURE OF A TEMPORARY CHARACTER, TRAILER, BASEMENT, TENT, SHACK, GARAGE, CAMPER, MOBILE HOME OR OTHER OUTBUILDING SHALL BE USED ON THE LOT AT ANY TIME AS A RESIDENCE.
- 2. NO INOPERATIVE OR UNLICENSED VEHICLES MAY BE PLACED ON LOT.
- 3. NO ACCUMULATION OF DISCARDED PERSONAL EFFECTS, DEBRIS, WASTE, GARBAGE OR ANY UNSIGHTLY OBJECTS OR MATERIAL WILL BE PERMITTED ON ANY LOT.
- 4. NO NOXIOUS OR OFFENSIVE ACTIVITY SHALL BE CARRIED ON UPON ANY LOT.
- 5. BEFORE ANY CONSTRUCTION TAKES PLACE, THE PURCHASER MUST CONTACT THE LOCAL GOVERNMENT AUTHORITY TO MAKE SURE THEY ARE IN COMPLIANCE WITH THE LOCAL LAWS.
- 6. BEFORE OCCUPANCY OF ANY HOUSE, A SEWAGE DISPOSAL SYSTEM SHALL BE INSTALLED TO CONFORMITY WITH THE MINIMUM STANDARDS REQUIRED BY THE COUNTY BOARD OF HEALTH.
- 7. NO SWINE OR LIVESTOCK OF ANY KIND SHALL BE RAISED, BOARDED, BRED OR KEPT ON LOT, EXCEPTING POULTRY, DOGS, CATS OR OTHER HOUSEHOLD PETS.
- 8. POULTRY, DOGS, CATS AND OTHER HOUSEHOLD PETS SHALL NOT BE BRED OR MAINTAINED FOR COMMERCIAL PURPOSES.
- NO DRILLING FOR OR THE EXTRACTION OF ANY MINERALS CAN BE CARRIED OUT ON LOT.
- 10. NO SOIL, TREES OR MINERALS CAN BE REMOVED FROM LOT FOR COMMERCIAL PURPOSES.
- 11. ANY FIRES ON LOT SHALL BE CONTAINED, ENCLOSED AND CAREFULLY SUPERVISED.
- 12. INVALIDATION OF ANY OF THESE COVENANTS BY JUDGEMENT OF COURT ORDER SHALL, IN NO WAY AFFECT ANY OF THE OTHER PROVISIONS, WHICH SHALL REMAIN IN FULL FORCE AND EFFECT.
- 13. NOTHING CONTAINED HEREIN SHALL BE CONSTRUED AS CREATING ANY OBLIGATION ON THE PART OF HOLIDAY INDUSTRIES LLC TO ENFORCE THESE PROTECTIVE COVENANTS.
- 14. THE PURCHASERS OF THIS LOT, FOR THEMSELVES, THEIR HEIRS AND ASSIGNS, BY THE ACCEPTANCE OF THE CONVEYANCE OF SAID LOT, AGREE TO BE BOUND BY THE COVENANTS CONTAINED HEREIN.
