Located 1/2 mi. south of S. Lake Road and 1/2 mi. east of the Basic School Road Alignment.

Red Globe | 44± acres, planted in 2009 - 3 year average 1,195 boxes per acre
Scarlet Royal | 80± acres, planted in 2009 - 3 year average 1,018 boxes per acre
Autumn King | 36± acres, planted in 2009 - 3 year average 1,087 boxes per acre

WATER

The Exitus I vineyard is within the Wheeler Ridge-Maricopa Water Storage District and receives full contract water. Irrigation is provided by an outlet at the filter system and pumps from the reservoir.

SOILS

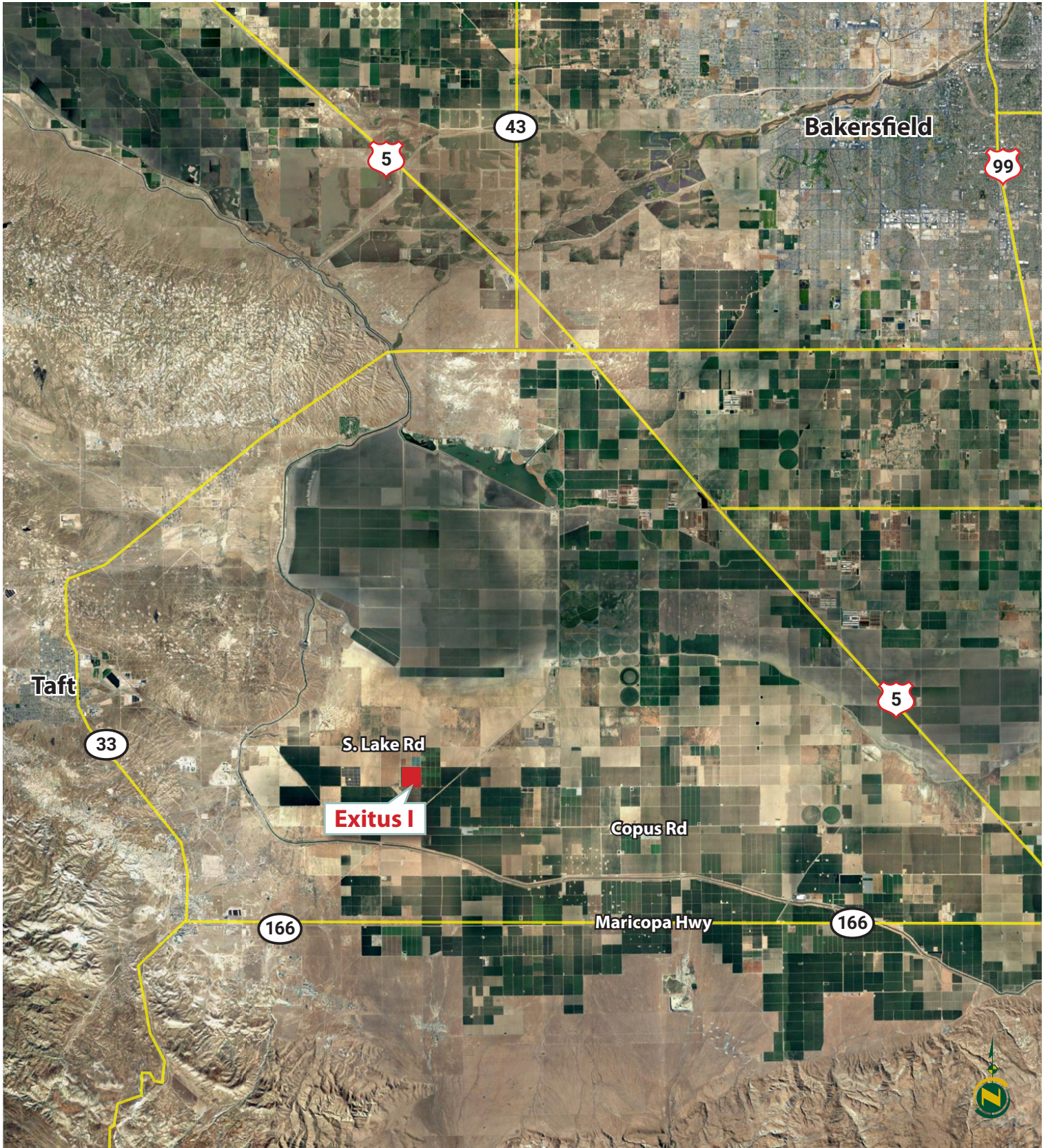
Cerini loam, 0 to 2 percent slopes, Grade 1 soils.

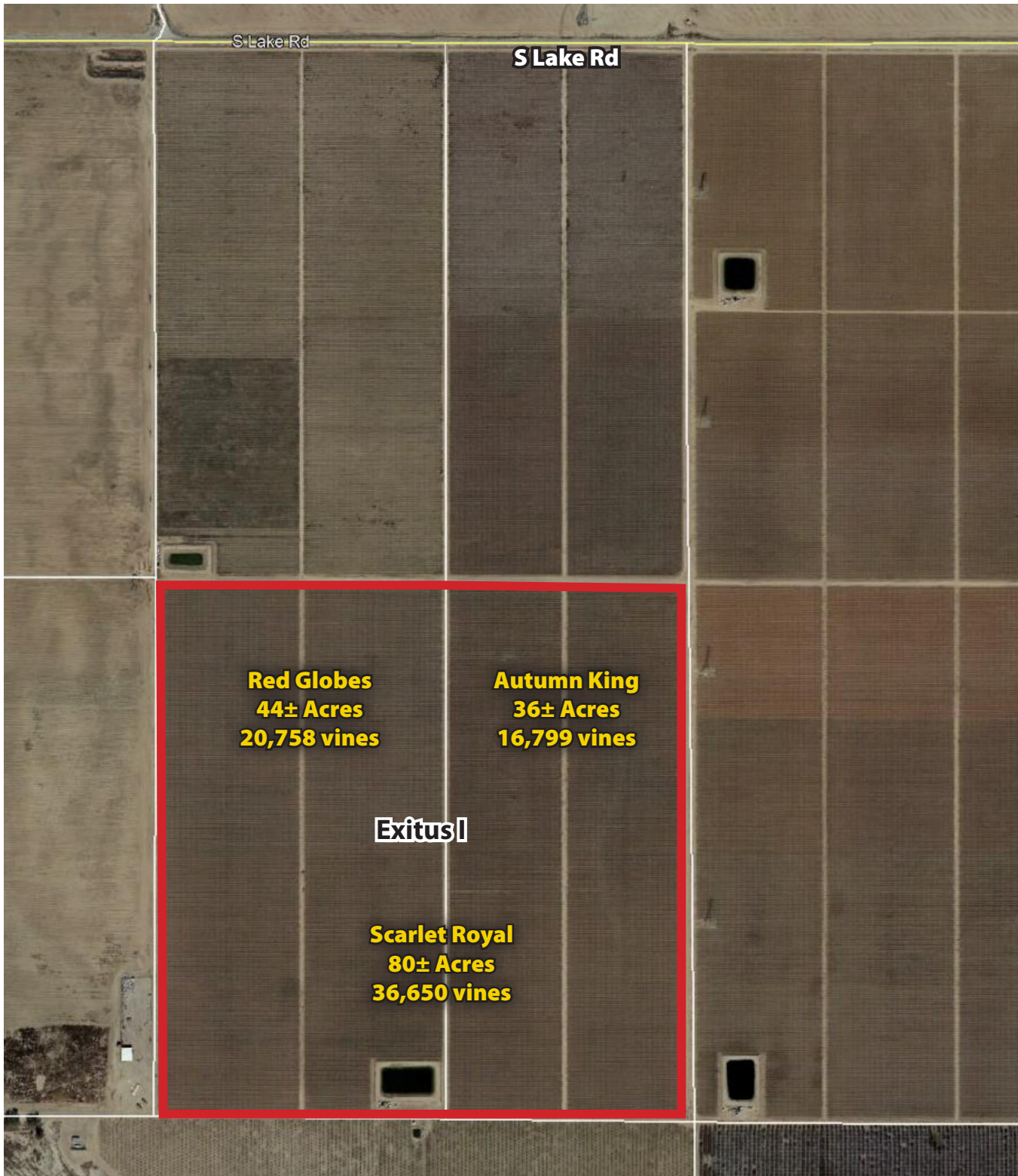

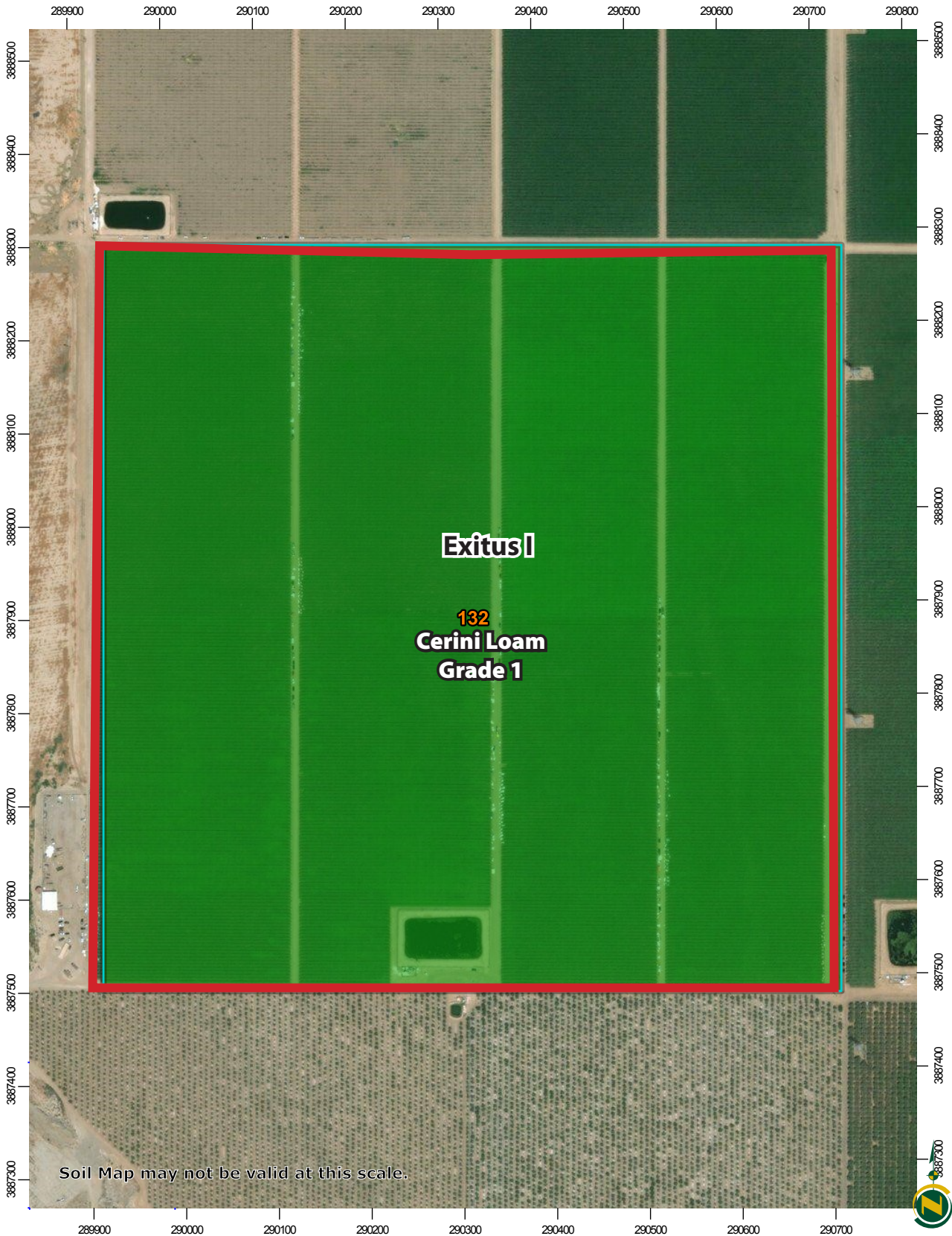




PLANTING MAP

Exitus I

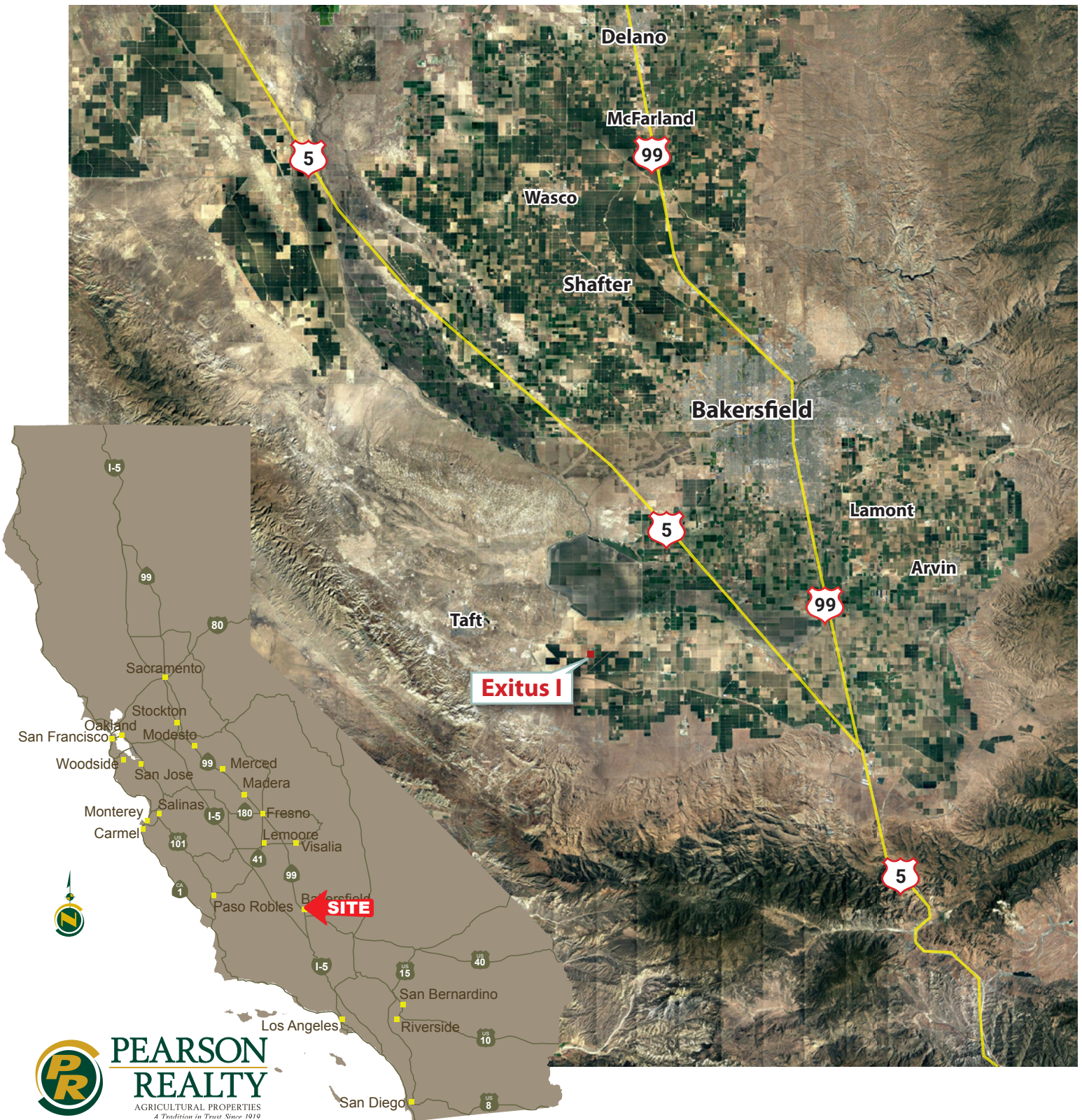
