113.44 ACRES ADJOINING JACKSONVILLE

This 113.44 acre tract of Morgan County land is strategically located, providing flexibility for future uses. For those seeking high-caliber farmland with excellent Class A soil types and a high percentage of tillable acreage, it's an attractive option to gain additional farmable acreage. Of the 113.44 acres, $109\pm$ (96%) are tillable and carry a Productivity Index Rating of 138.4 on a 147 point scale. The land is accessed at two points, one from Lincoln Avenue and another from Massey Lane. The gently rolling topography assists with the farm's drainage capabilities. Approximately 1.5 acres are enrolled in CRP along the Northwest edge of the property.

If commercial or residential development is the goal, its proximity to neighboring businesses and high-priced residential lots give it extraordinary potential. The Northeastern section of the property adjoins the largest chain home improvement retailer in a 25 mile radius. Jacksonville is home to nearly 20,000 residents, the largest local hospital, three colleges, manufacturing industries and much, much more. It is the hub for many neighboring rural communities, so the opportunities for future development are wide-ranging.
