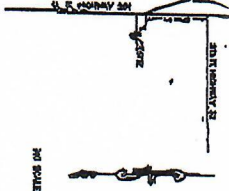

LOCATION MAP

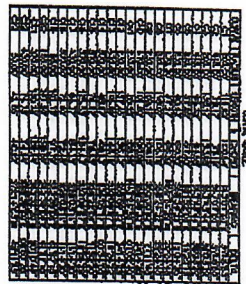

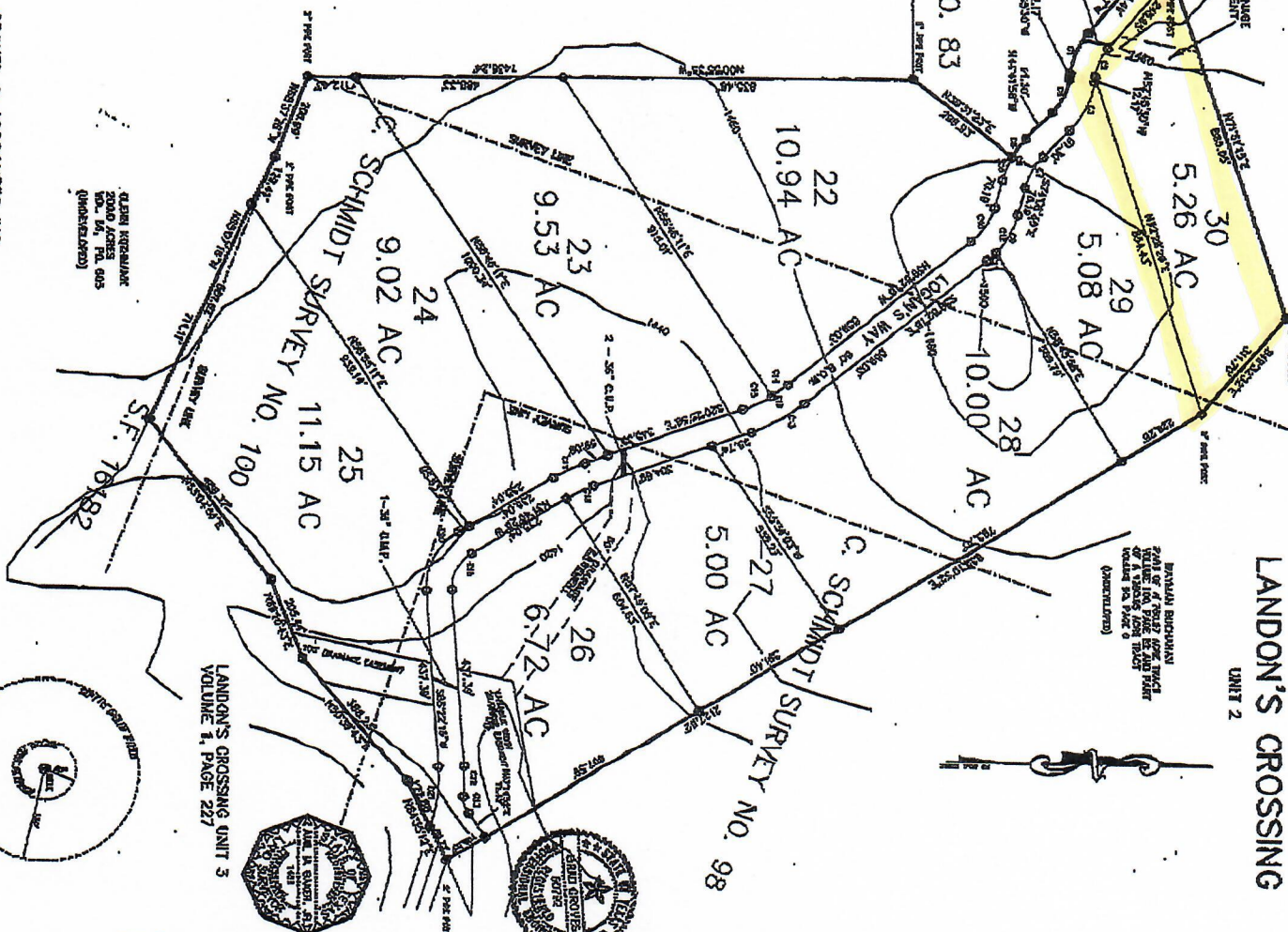
