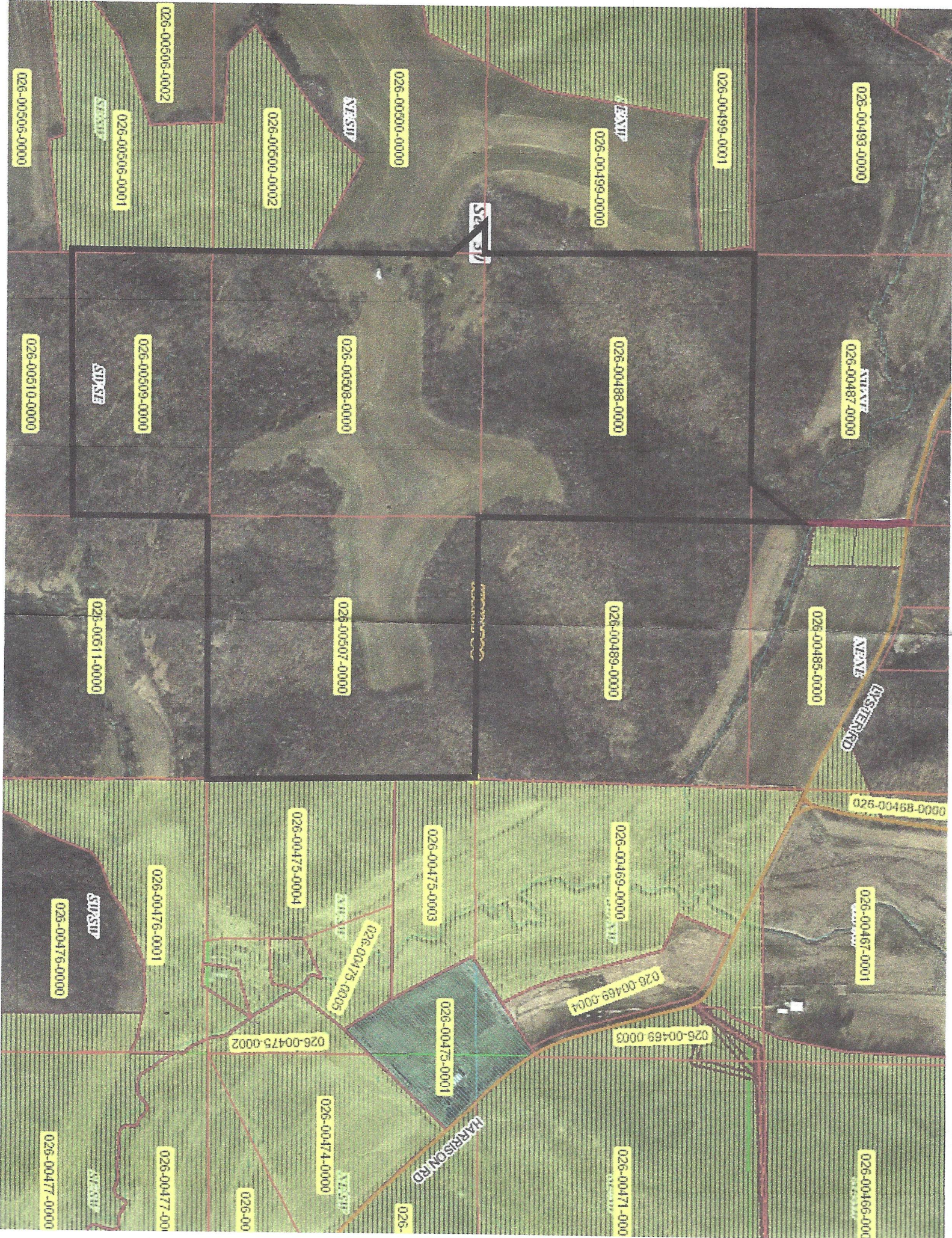




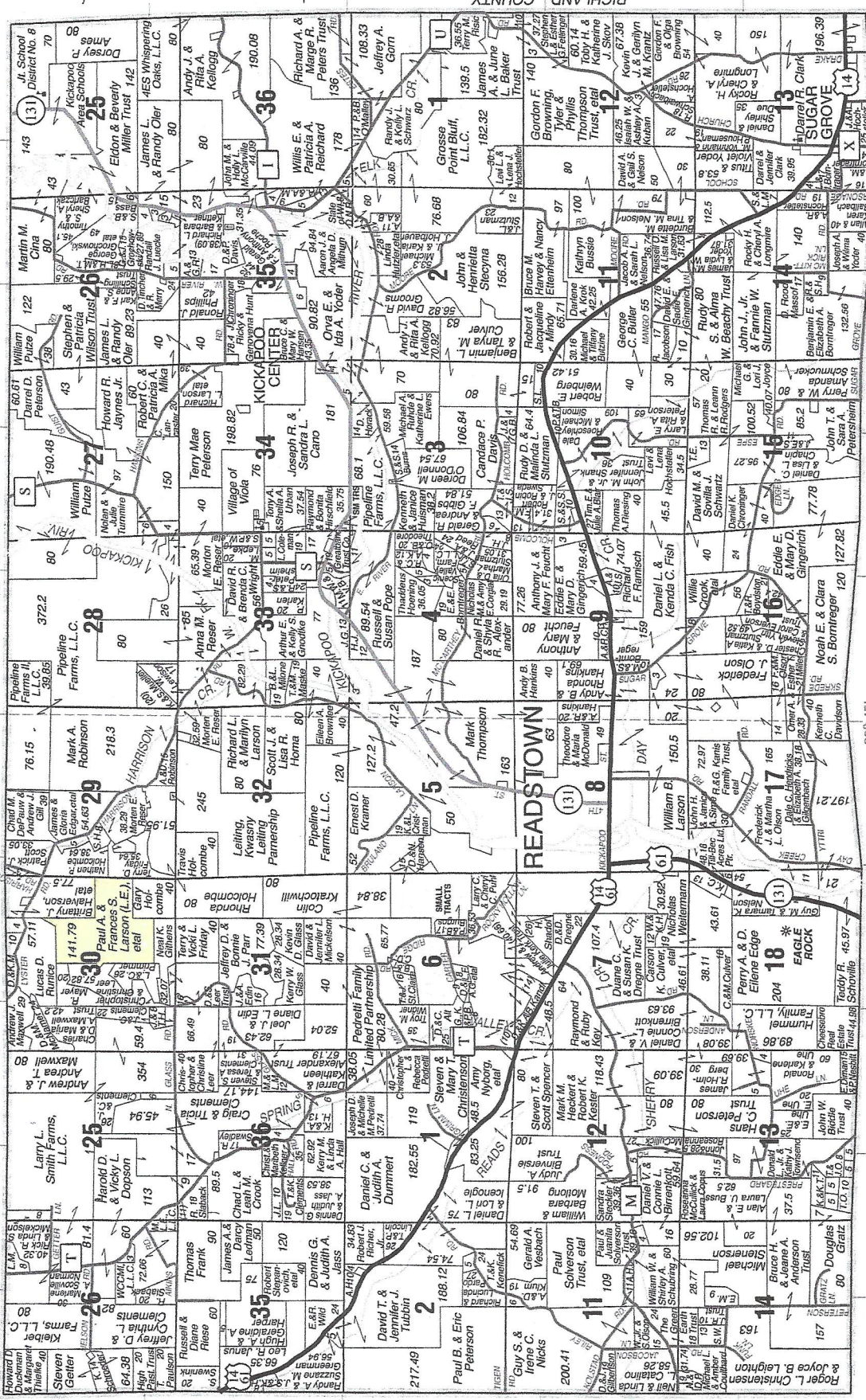

WARRANTY DEED

THIS INDENTURE WITNESSETH that the Grantors, PAUL A. LARSON and FRANCES S. LARSON, individually and as husband and wife, of the City of Little Rock in the County of Pulaski and State of Arkansas, for the consideration of One Dollar, in hand paid, convey and warrant to PAUL A. LARSON, JR. and DONNA LARSON of Dallas, Texas, in Joint Tenancy and not as Tenants in Common, as to an undivided one-half; and GILBERT G. LARSON and DAWN M. LARSON of Oswego, Illinois, in Joint Tenancy and not as Tenants in Common, as to an undivided one-half, the following real estate located in Vernon County, State of Wisconsin:

The North one-half of the Southeast Quarter (N 1/2 SE 1/4);

The North one-half of the Southwest Quarter of the Southeast Quarter (N 1/2 SW 1/4 SE 1/4);

The Southwest Quarter of the Northeast Quarter (SW 1/4 NE 1/4);

Part of the Northwest Quarter of the Northeast Quarter (NW 1/4 NE 1/4), commencing eleven (11) rods West of the Southeast corner, thence East eleven (11) rods to the Southeast corner, thence North to the creek about twenty-three (23) rods, thence in a straight line to the place of beginning.

Also a right of way over and across the easterly twenty-four (24) feet of that part of the Northwest Quarter of the Northeast Quarter (NW 1/4 NE 1/4), lying South of the town highway.
