

ALL that certain tract of land in Anderson Jounty, Texas, in the ROWLAND ALLEN SURVEY, Abstract 90 being comprised of Tract One called 33.61 acres and Tract Two called 1-1/2 acres in deed from Richard Alan Webb, et ux to Michael Craig Webb, et ux dated February 1, 1999, recorded in Volume 1578, Page 415 of the Anderson County Official Public Records (O.P.R.) and being more particularly described as follows:

BEGINNING at a 1/2" iron rod set in the North right-of-way line of U. S. Highway 287 (120 feet wide) at its intersection with the center of the old Palestine-Tennessee Colony Road, being the Easterly corner of said 1-1/2 acre tract and a Southwest corner of a tract called 35.76 acres in Volume 1064, Page 290 O.P.R.

THENCE; In a Westerly direction with the North right-of-way line, being a curve to the right having a central angle of 00° 20' 07", a radius of 2231.83, a length of 13.06 feet and a chord bearing N 76° 06' 41" W, 13.06 feet to the end of curve.

THENCE; N 75° 56' 37" W, with the North right-of-way line 611.17 feet to a 1/2" iron rod found marking the Southeast corner of the Second Tract called 30.10 acres in Volume 1805, Page 585 O.P.R.

THENCE; N 28° 34' 11" E, with the East line of the 30.10 acre tract 238.09 feet to a 60d nail found in the center of the old Palestine-Tennessee Colony Road at the Southeast corner of the First Tract called 38.5 acres in Volume 1805, Page 585 O.P.R.

THENCE; N 27° 00' 00" E, with the East line of the 38.5 / acre tract 1606.73 feet to a cross-tie fence corner found marking the Northeast corner of the 38.5 acre tract.

THENCE; N 62° 09' 25" W, with the North line of the 38.5 acre tract 307.37 feet to a calculated corner on the Southerly bank of Keechi Creek, being a Southerly corner of the residue of Tract One called 189 acres in Volume 1468, Page 549 O.P.R. as defined by a Boundary Line Agreement in Volume 1064, Page 290 O.P.R. Found a 1/2" iron rod S 62° 09' 25" E, 15.00 feet for reference.

THENCE; In a Northerly direction along an old fence described in said Boundary Line Agreement and the Southeast line of the residue of the 189 acre tract as follows:

N 70° 22' 43" E, 175.42 feet to a 1/2" iron rod found.

N 57° 03' 56" E, 125.58 feet to an 18" Black Jack Tree.

N 30° 59' 36" E, 54.34 feet to a 1/2" iron rod found.

N 01° 45' 43" W, 231.28 feet to a 1/2" iron rod found.

N 12° 40' 18" E, 448.98 feet to a 1/2" iron rod found.

N 84° 14' 14" E, 85.31 feet to a metal T-post found.

Found an axle N 22° 24' 48" E, 51.89 feet for reference.

THENCE; In a Southeasterly direction with the center of the old Palestine-Tennessee Colony Road and a Southerly line of the 35.76 acre tract, being a curve to the left having a central angle of 04° 55' 42", a radius of 2457.85 feet, a length of 211.42 feet and a chord bearing S 59° 10' 19" E, 211.35 feet to the PLACE OF BEGINNING containing 29.398 acres.

Bearings are based on the lower West line of the 33.61 acre tract in Volume 1578, Page 415 O.P.R. Called N 27° E.
