Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

## **Application History**

Permit S-54563 was issued by the Department on June 11, 2009. The permit specified completion of construction and complete application of water to beneficial use by June 11, 2014. On September 11, 2017, Glenn and Susanne Howard submitted an Application for Extension of Time for Permit S-54563. In accordance with OAR 690-315-0050(2), on October 24, 2017, the

Department issued a Proposed Final Order proposing to extend the time to complete construction from June 11, 2014, to October 1, 2019, and the time to apply water to full beneficial use from June 11, 2014, to October 1, 2019. The protest period closed December 8, 2017, in accordance with OAR 690-315-0060(1). No protest was filed.

### FINDINGS OF FACT

The Department adopts and incorporates by reference the findings in the Proposed Final Order dated October 24, 2017.

At time of issuance of the Proposed Final Order the Department concluded that, based on the factors demonstrated by the applicant, the permit may be extended subject to no additional conditions.

## **CONCLUSION OF LAW**

The applicant has demonstrated good cause for the permit extension pursuant to ORS 537.230, 539.010(5) and OAR 690-315-0040(2).

## **ORDER**

The extension of time for Application S-87356, Permit S-54563, therefore, is approved subject to conditions contained herein. The deadline for completing construction is extended from June 11, 2014, to October 1, 2019. The deadline for applying water to full beneficial use within the terms and conditions of the permit is extended from June 11, 2014, to October 1, 2019.
