Pursuant to your request, I have made an appraisal of the timber value on the Oakmont Tract of timberland in Spartanburg County, South Carolina, tax ID # 2-24-00-018.00 and 2-24-00-024.01, containing approximately 200 acres. Of the 200 acres, approximately 194 acres is considered timberland with merchantable timber. The volume was derived by performing a 6.5% cruise on a systematic chain-grid basis. The property and stand boundaries used were estimated from the tract and county maps and identified during field work conducted on this property. There is a volume and value table included with this report. The per-unit values used are guided by current Timber Mart South prices from the 2nd quarter of 2018, but due to the geographic location and the terrain of the property, the total timber value is based on the current prices that have been offered on similar timber in the area.

Based on my findings, I estimate the present value of the standing timber (stumpage) on the property to be:

This estimate assumes that all timber on the property would be offered for sale on the open market within 30 days of the above date with no unusual restrictions placed on the buyer. This estimate also includes the value of trees that should be left uncut along streams to protect water quality and comply with South Carolina's Best Management Practices (BMP's). Based on my observations, it is estimated that BMP compliance and steep terrain would result in an 8 to 10 percent reduction in the total value.
