

FIELD NOTE DESCRIPTION OF THE SURVEY OF A 11.11 ACRE (483,776.64 SQUARE FEET) TRACT OF LAND OUT OF A 12.67 ACRE TRACT OF LAND OUT OF THE NW/4 OF SECTION 34, BLOCK 38, T-1-S, T&P RR CO SURVEY, MIDLAND COUNTY, TEXAS, SAID 11.11 ACRE TRACT BEING DESCRIBED MORE FULLY BY METES AND BOUNDS AS FOLLOWS:

BEGINNING AT A 5/8" REINF BAR FOUND FOR THE NW CORNER OF THIS TRACT, SAME BEING THE NW CORNER OF SAID 12.67 ACRE TRACT, FROM WHICH THE NW CORNER OF SAID SECTION 34 BEARS S.74"33"15"W. 1988.78 FEET AND N.15"38"09"W. 825.00 FEET;

THENCE N.74°33'15"E. 280.51 FEET ALONG THE NORTH LINE OF SAID 12.67 ACRE TRACT TO A 1/2" REINF BAR SET FOR THE MOST NORTHERLY NE CORNER OF THIS TRACT IN THE SOUTH RIGHT-OF-WAY LINE OF EAST LOOP 250 NORTH;

THENCE S.63"21"00"E. 451.33 FEET ALONG THE SOUTH RIGHT-OF-WAY LINE OF EAST LOOP 250 NORTH TO A 4x4 CONCRETE HIGHWAY MONUMENT FOUND AT THE "PT" OF A CURVE TO THE LEFT;

THENCE 64.12 FEET ALONG SAID CURVE TO THE LEFT (CURVE DATA AS FOLLOWS: RADIUS=1759.88'; CENTRAL ANGLE=02'15'15"; TANGENT=32.06' CHORD=S.71"51'21"E. 64.11') TO A POINT AT THE INTERSECTION OF THE CENTERLINE OF NORTH COUNTY ROAD 1135 WITH EAST LOOP 250 NORTH FOR THE MOST EASTERLY NE CORNER OF THIS TRACT IN THE EAST LINE OF SAID 12.67 ACRE TRACT;

THENCE S.15"29"08"E. (REC. S.15"38"09"E.) 486.26 FEET ALONG THE CENTERLINE OF NORTH COUNTY ROAD 1135 TO A POINT FOR THE SE CORNER OF THIS TRACT, SAME BEING THE SE CORNER OF SAID 12.67 ACRE TRACT;

THENCE S.74'30'11"W. (REC. S.74'33'15"W.), AT 30.00 FEET PASS A 1/2" REINF BAR FOUND IN THE WEST RIGHT-OF-WAY LINE OF NORTH COUNTY ROAD 1135, IN ALL A TOTAL DISTANCE OF 668.78 FEET TO A 1/2" REINF BAR FOUND FOR THE SW CORNER OF THIS TRACT, SAME BEING THE SW CORNER OF SAID 12.67 ACRE TRACT;

THENCE N.15"29"08"W. 825.07 FEET (REC. N.15"38"09"W. 825.00") TO THE PLACE OF BEGINNING.


