## AGREEMENT TO MODIFY SETBACK REQUIREMENTS FOR LOT 36 DANCING BEAR RANCH SUBDIVISION, UNIT ONE MEDINA COUNTY, TEXAS AS RECORDED IN VOLUME 8, PAGE 172-182 PLAT RECORDS OF MEDINA COUNTY, TEXAS

## NOW, THEREFORE, THE PARTIES AGREE AS FOLLOWS:

- 1. The front yard building setback line for the property described as Lot 36, Dancing Bear Ranch, Unit One, a subdivision in Medina County, Texas, as recorded in Volume 8, Page 172-182 of the Plat Records of Medina County, Texas, is hereby reduced from 25' to 10'; and,
- 2. All other covenants, conditions and restrictions affecting the property as found in Volume 42, Page 846 of the Official Public Records of Medina County, Texas shall remain in full force and effect.
