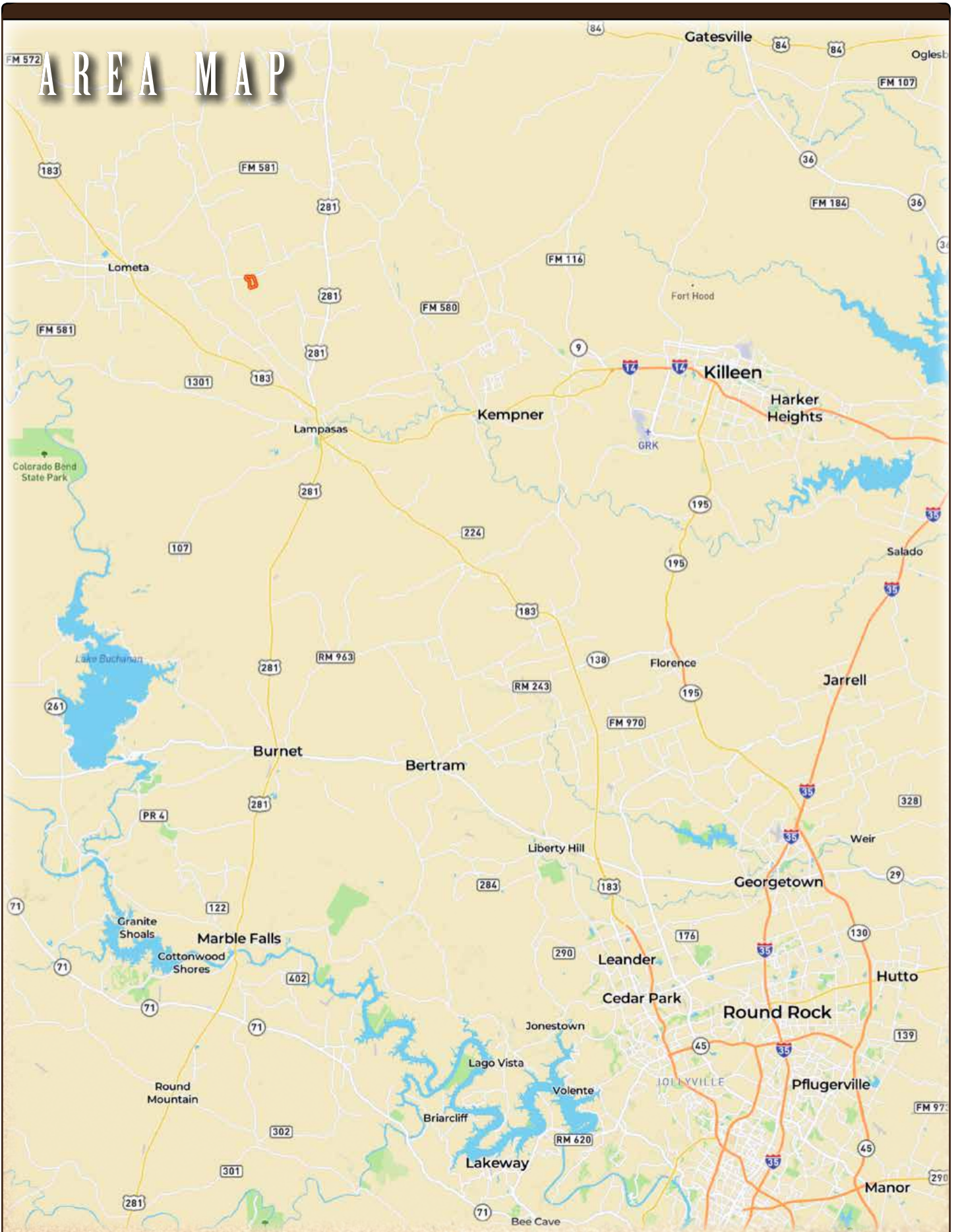
## **Buck Hollow is an outstanding Hill Country ranch, with a lot to offer.**

Located on paved CR 2275, the property is around 15 minutes from Lampasas, an hour from Georgetown, Cedar Park/Leander, and an hour and an hour and a half from central Austin. Lampasas provides medical facilities and has an HEB, Walmart, and Tractor Supply for various shopping needs. The Lampasas Municipal Airport is a general aviation airport consisting of a 4,200-foot runway (extendable to 5,000 feet) with an Instrumental Flight Rules approach, a small terminal / lounge building, tee hangars, nine aircraft tie-down spaces, and Automated Weather Observation System (AWOS) that is accessible by telephone or aircraft radio, a cement pad for use by emergency evacuation helicopters and a 24-hour self-service fuel dispensing facility.

When you enter the property, the ranch road winds through motts of oaks and along small meadows until you come to School Creek. An impressive concrete crossing allows access across the creek. The crossing creates a dam that backs up a nice stretch of water. There is 2,500+/- feet of School Creek winding through the ranch. The creek is clear flowing, has a rock bottom, and has scenic limestone bluffs, yet is accessible in various locations. The banks are lined with huge hardwoods. The land has varied topography, with elevations ranging from 1,180 feet to 1,300 feet. There are several building sites with scenic views of the surrounding countryside and take advantage of the southeastern breezes. There is good tree cover consisting of Live Oak, Elm, Spanish Oak, Pecan, Cedar, Sycamore, and Mesquite. The lower elevations have meadows that are ideal for food plots or improved grasses. A feeder creek and/or a deep draw offers the opportunity for a pond or lake. There is a well and electricity on the property. The hunting should be excellent due to the ranch not being hunted for many years. Wildlife includes deer, turkey, dove, and hogs. Occasionally quail can be seen or heard.

If you are looking for a great live water ranch for hunting, recreation, or a home place, then Buck Hollow is worth a serious look.

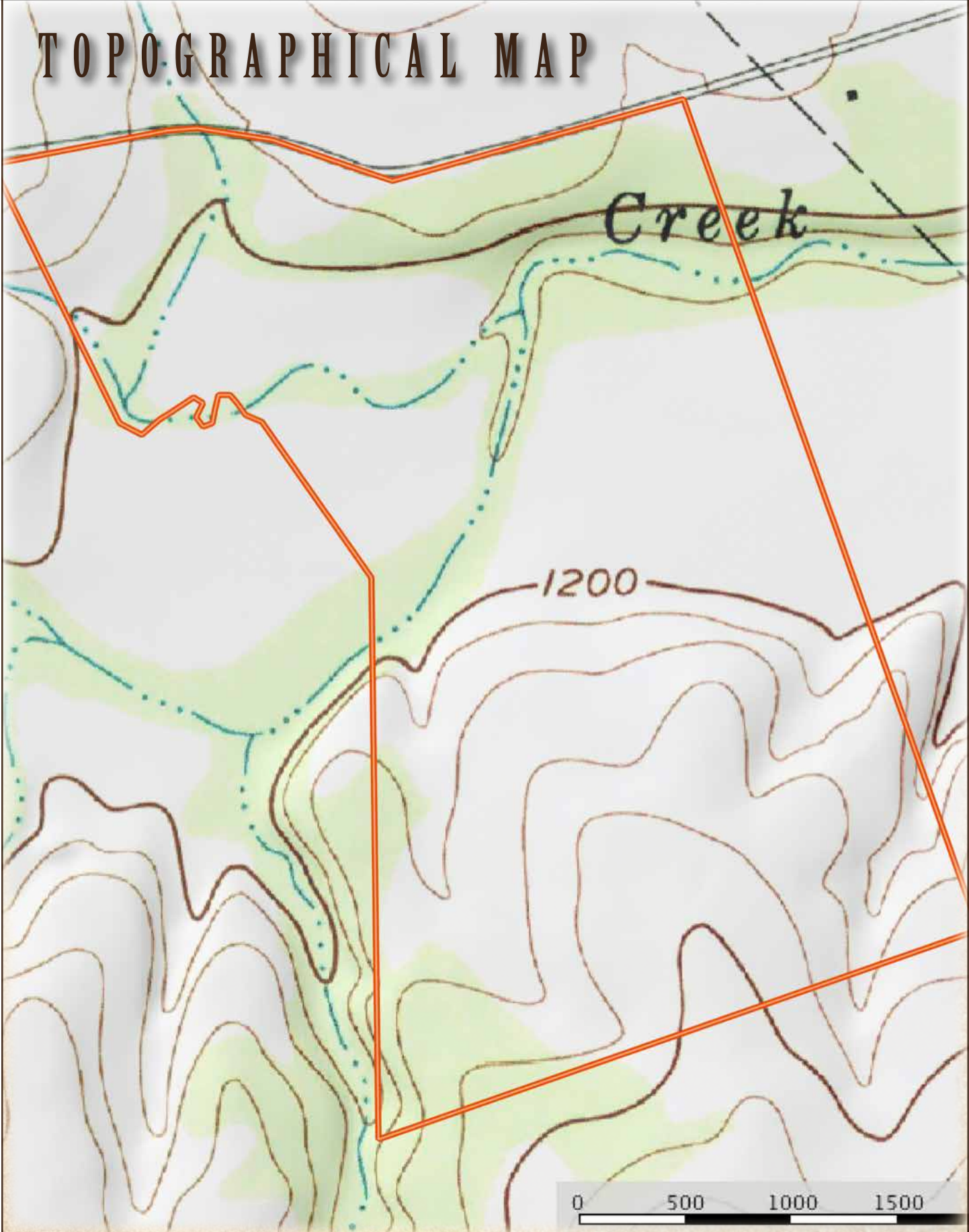
# AREA MAP



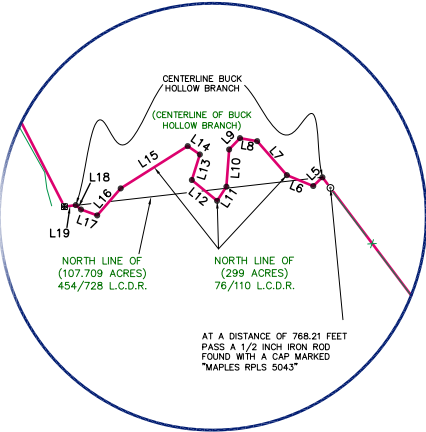
# AERIAL MAP



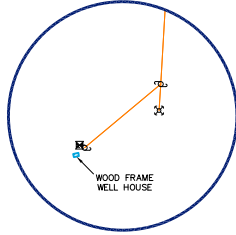
# TOPOGRAPHICAL MAP

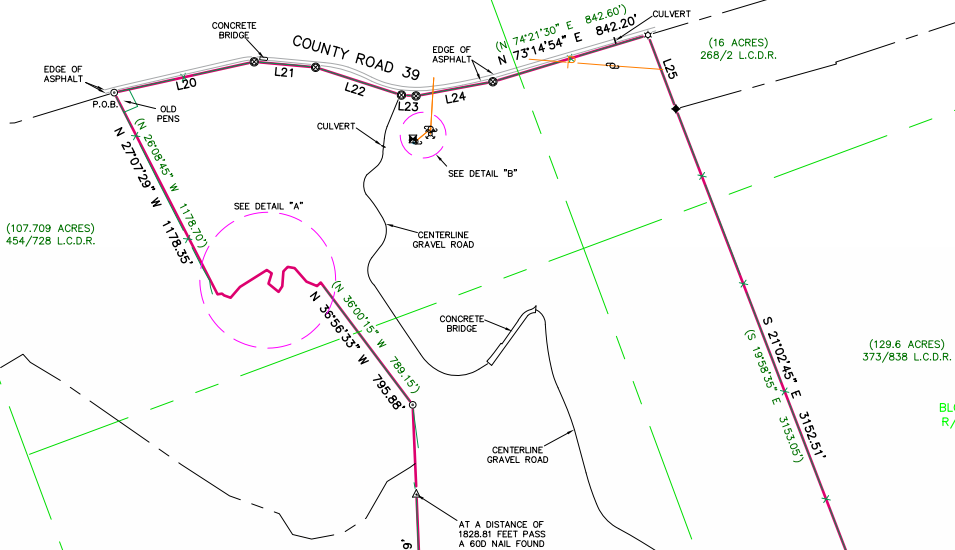

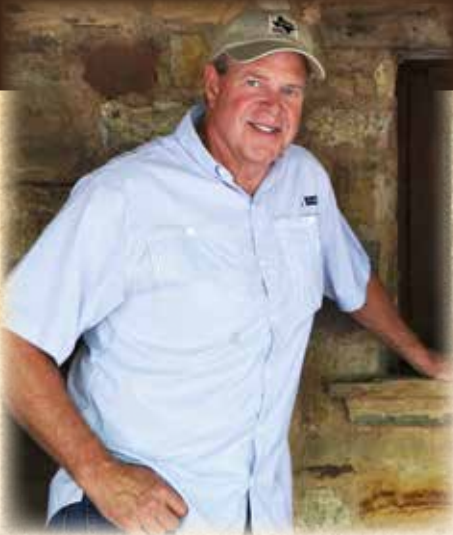

# Information About Brokerage Services

Texas law requires all real estate licensees to give the following information about brokerage services to prospective buyers, tenants, sellers and landlords.

**TYPES OF REAL ESTATE LICENSE HOLDERS:**

- A **BROKER** is responsible for all brokerage activities, including acts performed by sales agents sponsored by the broker.
- A **SALES AGENT** must be sponsored by a broker and works with clients on behalf of the broker.

**A BROKER'S MINIMUM DUTIES REQUIRED BY LAW (A client is the person or party that the broker represents):**

- Put the interests of the client above all others, including the broker's own interests;
- Inform the client of any material information about the property or transaction received by the broker;
- Answer the client's questions and present any offer to or counter-offer from the client; and
- Treat all parties to a real estate transaction honestly and fairly.

**A LICENSE HOLDER CAN REPRESENT A PARTY IN A REAL ESTATE TRANSACTION:**

**AS AGENT FOR OWNER (SELLER/LANDLORD):** The broker becomes the property owner's agent through an agreement with the owner, usually in a written listing to sell or property management agreement. An owner's agent must perform the broker's minimum duties above and must inform the owner of any material information about the property or transaction known by the agent, including information disclosed to the agent or subagent by the buyer or buyer's agent.

**AS AGENT FOR BUYER/TENANT:** The broker becomes the buyer/tenant's agent by agreeing to represent the buyer, usually through a written representation agreement. A buyer's agent must perform the broker's minimum duties above and must inform the buyer of any material information about the property or transaction known by the agent, including information disclosed to the agent by the seller or seller's agent.

**AS AGENT FOR BOTH - INTERMEDIARY:** To act as an intermediary between the parties the broker must first obtain the written agreement of each party to the transaction. The written agreement must state who will pay the broker and, in conspicuous bold or underlined print, set forth the broker's obligations as an intermediary. A broker who acts as an intermediary:

- Must treat all parties to the transaction impartially and fairly;
- May, with the parties' written consent, appoint a different license holder associated with the broker to each party (owner and buyer) to communicate with, provide opinions and advice to, and carry out the instructions of each party to the transaction.
- Must not, unless specifically authorized in writing to do so by the party, disclose:
  - that the owner will accept a price less than the written asking price;
  - that the buyer/tenant will pay a price greater than the price submitted in a written offer; and
  - any confidential information or any other information that a party specifically instructs the broker in writing not to disclose, unless required to do so by law.

**AS SUBAGENT:** A license holder acts as a subagent when aiding a buyer in a transaction without an agreement to represent the buyer. A subagent can assist the buyer but does not represent the buyer and must place the interests of the owner first.

**TO AVOID DISPUTES, ALL AGREEMENTS BETWEEN YOU AND A BROKER SHOULD BE IN WRITING AND CLEARLY ESTABLISH:**

- The broker's duties and responsibilities to you, and your obligations under the representation agreement.
- Who will pay the broker for services provided to you, when payment will be made and how the payment will be calculated.
