24.193 Acre Tract

Field notes describing a 24.193 acre tract out of Unit 6 of Greentree Village of Waterwood Subdivision, out of the Sallie E. Gibbs Survey, Abstract 418, San Jacinto County, Texas. Said Unit 6 is shown on a plat recorded in Volume 4, Page 37 of the Plat Records of San Jacinto County, Texas. Said Unit 6 is more particularly described as the Fourth property being 204.314 acres and recorded in Volume 214, Page 648 of the Deed Records of San Jacinto County, Texas.

NOTE: All the horizontal control is referred to the Texas State Plane Coordinate System, Lambert Projection, NAD 27 Datum, Central Zone. All bearings, distances and acreages are grid. The theta correction at a $\frac{1}{2}$ " iron rod found at the northwest corner of a Waterwood Improvement Associtation 5.870 acre tract as described in Clerk's File #02-2161, Page 9058 of the Official Public Records of San Jacinto County, Texas is +02°36'51" and the scale factor is 0.999887209. (See Accompanying Plat)

BEGINNING at a 5/8" iron rod with a cap stamped "S&J INC." set for corner in the most southerly west line of a Docter 88.593 acre tract as described in Clerk's File #20196301, Page 31381 of the Official Public Records of San Jacinto County, Texas. Said beginning iron rod bears S 09°34'55" W 1817.43 feet from a 5/8" iron rod with a cap stamped "S & J INC." set at the most northerly northwest corner of said 88.593 acre tract. Said beginning iron rod also bears S 09°34'55" W 50.02 feet from a 5/8" iron rod with a cap stamped "S & J INC." set at the southeast corner of a Stubblefield 23.000 acre tract as described in Clerk's File #2019111358 of the Official Public Records of San Jacinto County, Texas. Said beginning iron rod has a Texas State Plane Coordinate Value of Y: 447,927.18 feet and X: 3,591,211.60 feet.

THENCE N 81°51'25" W along and with the most westerly south line of said 88.593 acre tract at 1650.94 feet pass a 5/8" iron rod with a cap stamped "S&J INC." set for reference in the east right-of-way line of Waterwood Parkway and at a **total distance of 1741.27 feet** a 5/8" iron rod with a cap stamped "S&J INC." set for corner in the centerline of said Parkway. Said Waterwood Parkway was dedicated to the public in Volume 214, Page 610 of the Official Public Records of San Jacinto County, Texas.

THENCE in a southwesterly direction along and with a curve to the right in the centerline of said Waterwood Parkway **249.78 feet** to a 5/8" iron rod with a cap stamped

"S & J INC." set for corner. Said curve to the right has a radius of 1845.02 feet, a central angle of 07°45'24" and a chord which bears S 17°08'56" W 249.59 feet.

THENCE **S 68°57'23" E 89.91 feet** to a 5/8" iron rod with a cap stamped "S&J INC." set for corner at the southwest corner of said Unit 6, the southwest corner of said 204.314 acre tract and the northwest corner of a Cowart 401.461 acre tract described in Volume 150, Page 122 of the Official Public Records of San Jacinto County, Texas, at the intersection of the east right-of-way line of said Parkway with the centerline of an unnamed branch.

THENCE along and with the north line of said 401.461 acre tract, the south line of said 204.314 acre tract and the centerline of said Branch with its meanders **generally** as follows:
