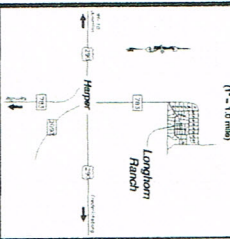


Location Map

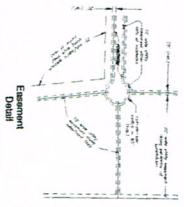
