WATER

There are 2 Irrigation wells. One well produces 700± GPM and the other produces 1,200± GPM. You are permitted 2.5-acre feet of water per contiguous acre per year. The River Pump from Espantosa Lake produces 1,500± GPM and is permitted for 2,500± acre feet of water per year which is 2-acre feet per contiguous acre per year. There is a second river pump that is located on the Nueces River. This farm has .85+/- miles of frontage on the Espantosa Lake and .5+/- miles of frontage along the Nueces river. This water frontage offers a beautiful setting along with recreational opportunities such as fishing and boating. There is a pond located in the center of the property and there are numerous water troughs in each pasture.









WILDLIFE

This farm could be turned into an exceptional dove hunting operation! The property is loaded with dove and can be planted and maintained to further improve the dove/quail Native wildlife hunting. present on the property includes but is not limited to whitetail deer, quail, turkey, dove, varmints and hogs. The ponds, lakes, and rivers have fish such as bass, perch, and catfish.
