I hereby state that all parts of this survey and drawing have been completed in accordance with the current requirements of the Standards of Practice for Surveying in the State of Alabama to the best of my knowledge, information and belief; the property described as follows:

Beginning at the Northeast corner of the South Half of the Northwest Quarter of Section 8, Township 1 North, Range 8 East, Escambia County, Alabama, said point being an existing capped iron (21578LS), and thence run North 80 degrees 31 minutes 31 seconds East for a distance of 1304.19 feet to a 1/2" near with cap (BLS-146735LS) at the Northwest corner of the West Half of the Northwest Quarter; thence run North 80 degrees 51 minutes 10 seconds East for a distance of 1319.85 feet to a 1/2" near with cap (BLS-146735LS) at the Northeast corner of said West Half of the Northwest Quarter; thence run South 80 degrees 31 minutes 31 seconds West for a distance of 2018.84 feet to a 1/2" near with cap (BLS-146735LS) at the Southwest corner of said West Half of the Northwest Quarter; thence run North 88 degrees 58 minutes 28 seconds West for a distance of 1315.09 feet to a 1/2" near with cap (BLS-146735LS) at the Southwest corner of said West Half of the Northwest Quarter; thence run South 88 degrees 31 minutes 31 seconds West for a distance of 1305.49 feet to a 1/2" near with cap (BLS-146735LS) at the Southwest corner of the North Half of the Southwest Quarter; thence run South 88 degrees 59 minutes 57 seconds West for a distance of 108.08 feet to a 1/2" near with cap (BLS-146735LS) on the East right of way of Whispering Pines Road (S27°34'N); thence run along said East right of way and a curve turning to the left with an arc length of 160.91', with a radius of 315.12', for a chord bearing of North 83 degrees 28 minutes 43 seconds West for a chord distance of 193.17 feet to a point; thence run North 78 degrees 23 minutes 24 seconds West along said East right of way line for a distance of 368.65 feet to a point; thence along said right of way and a curve turning to the right with an arc length of 236.75', with a radius of 318.38' for a chord bearing of North 58 degrees 13 minutes 10 seconds West for a chord distance of 236.19 feet to a point; thence run North 34 degrees 38 minutes 41 seconds West along said right of way line for a distance of 748.67 feet to a point; thence along said right of way and a curve turning to the left with an arc length of 226.48', with a radius of 775.38', for a chord bearing of North 48 degrees 21 minutes 38 seconds West for a chord distance of 225.86 feet to a point; thence run North 58 degrees 44 minutes 05 seconds West along said right of way line for a distance of 486.14 feet to a point; thence along said right of way and a curve turning to the right with an arc length of 515.23', with a radius of 526.80', for a chord bearing of North 38 degrees 23 minutes 42 seconds West for a chord distance of 499.56 feet to a point; thence run North 38 degrees 23 minutes 24 seconds West along said right of way line for a distance of 808.05 feet to a 1/2" near with cap (BLS-146735LS) on the North line of the South Half of the Northwest Quarter; thence leaving said East right of way line run North 38 degrees 50 minutes 52 seconds East for a distance of 2079.51 feet to the point of beginning. Said parcel lying in and being all of the West Half of the Northwest Quarter, all that part of the South Half of the Northwest Quarter lying East of Whispering Pines Road and all that part of the North Half of the Southwest Quarter lying East of Whispering Pines Road, all in Section 8, Township 1 North, Range 8 East, Escambia County, Alabama and containing 114.57 acres more or less.
