Camp 6 - North McMillan - Location Map

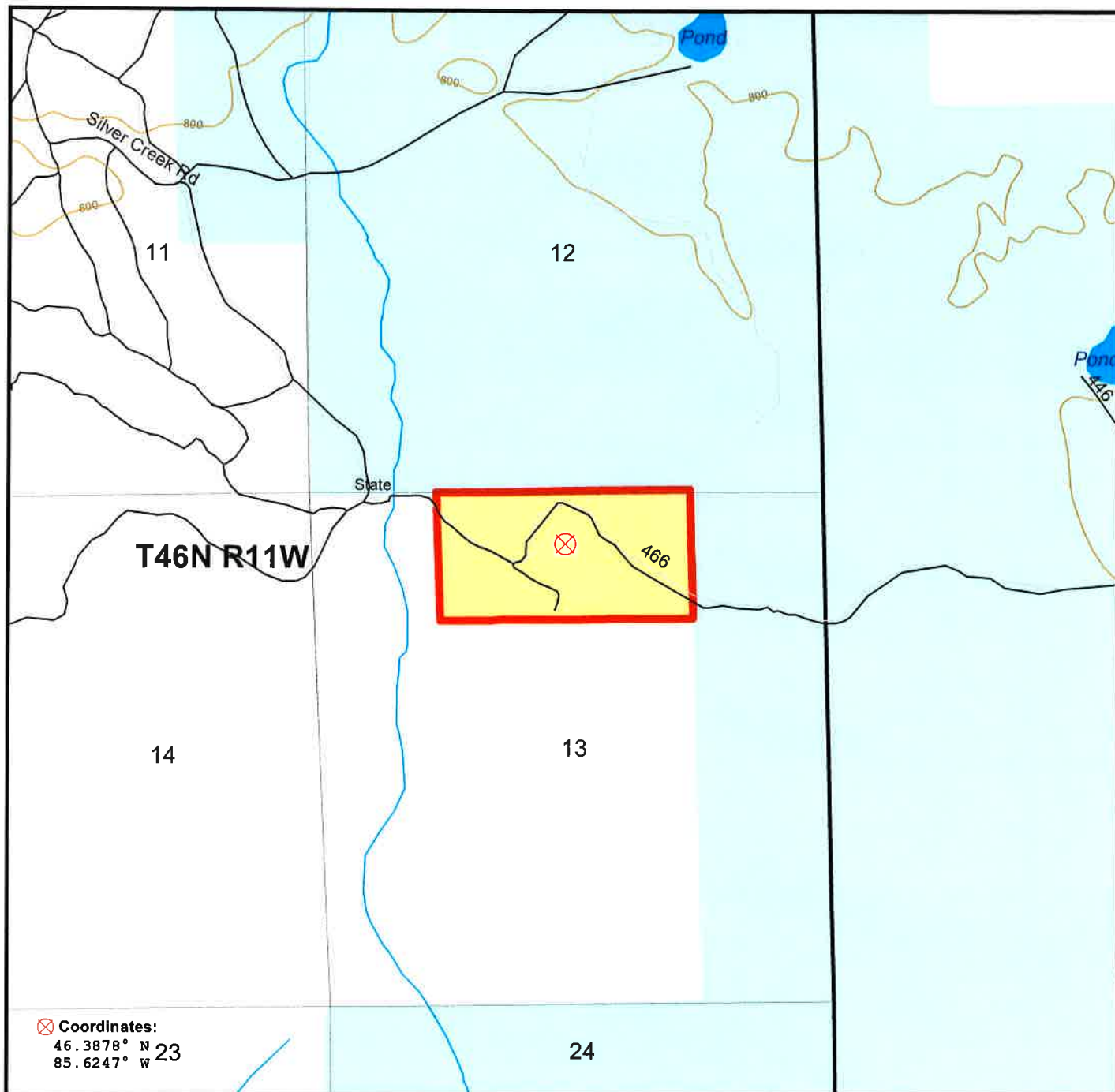

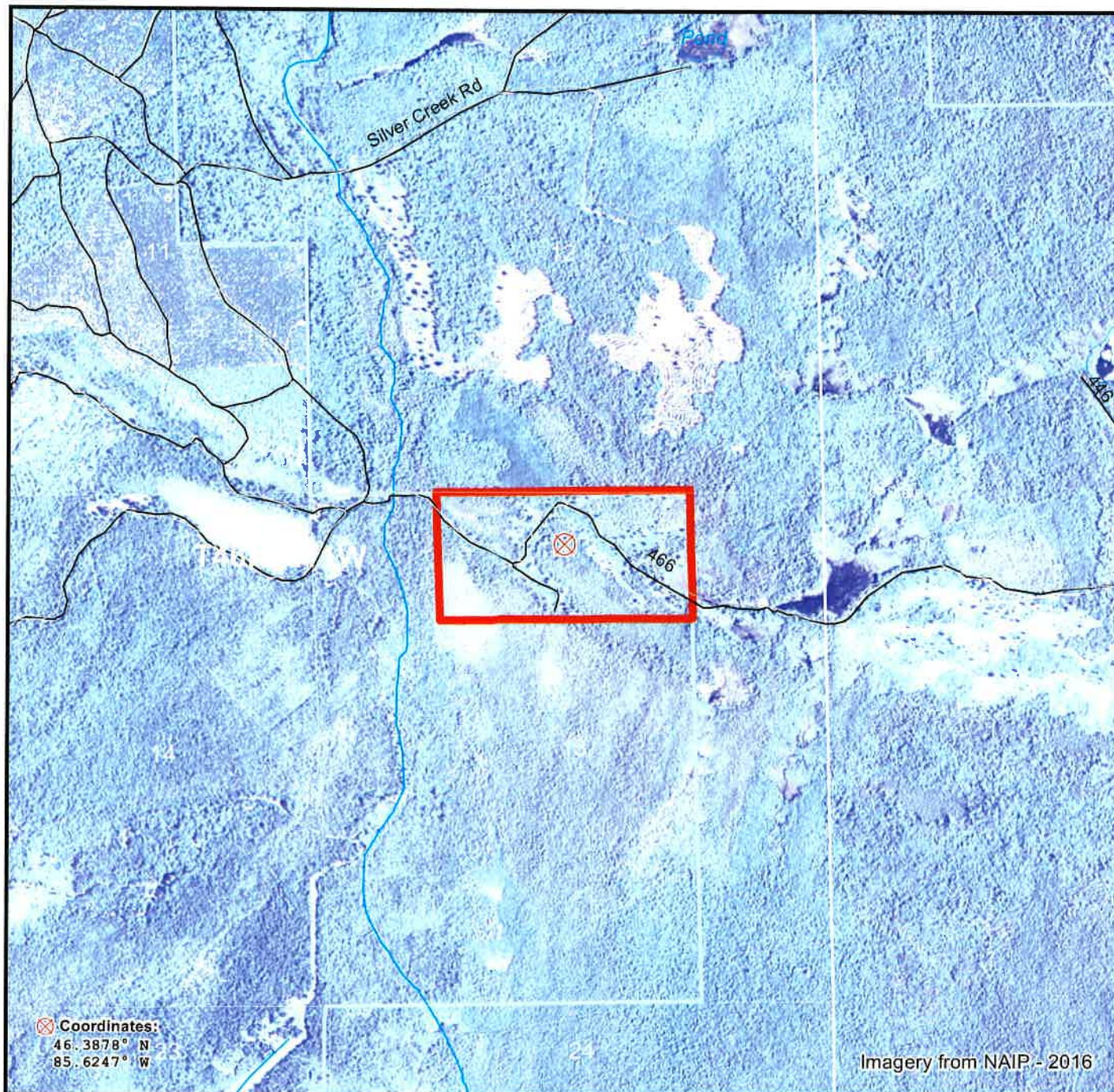


Camp 6 - North McMillan - Parcel Map

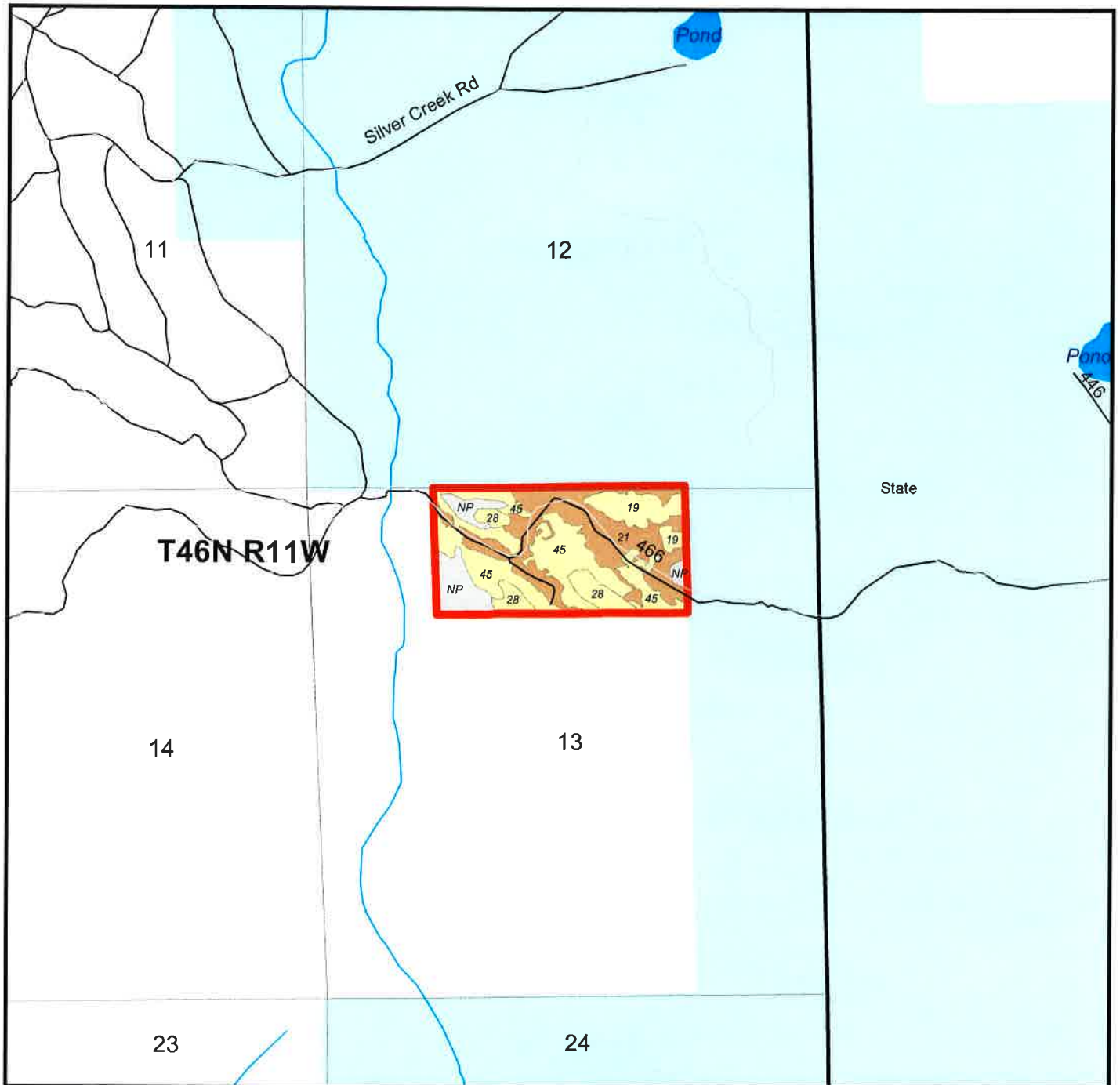

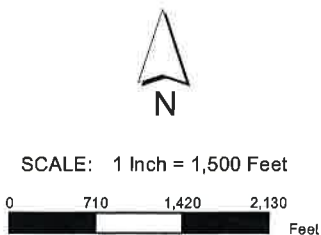
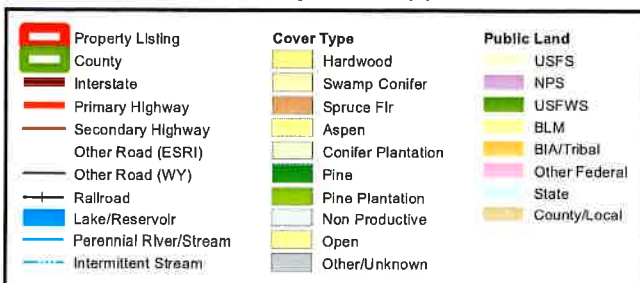
