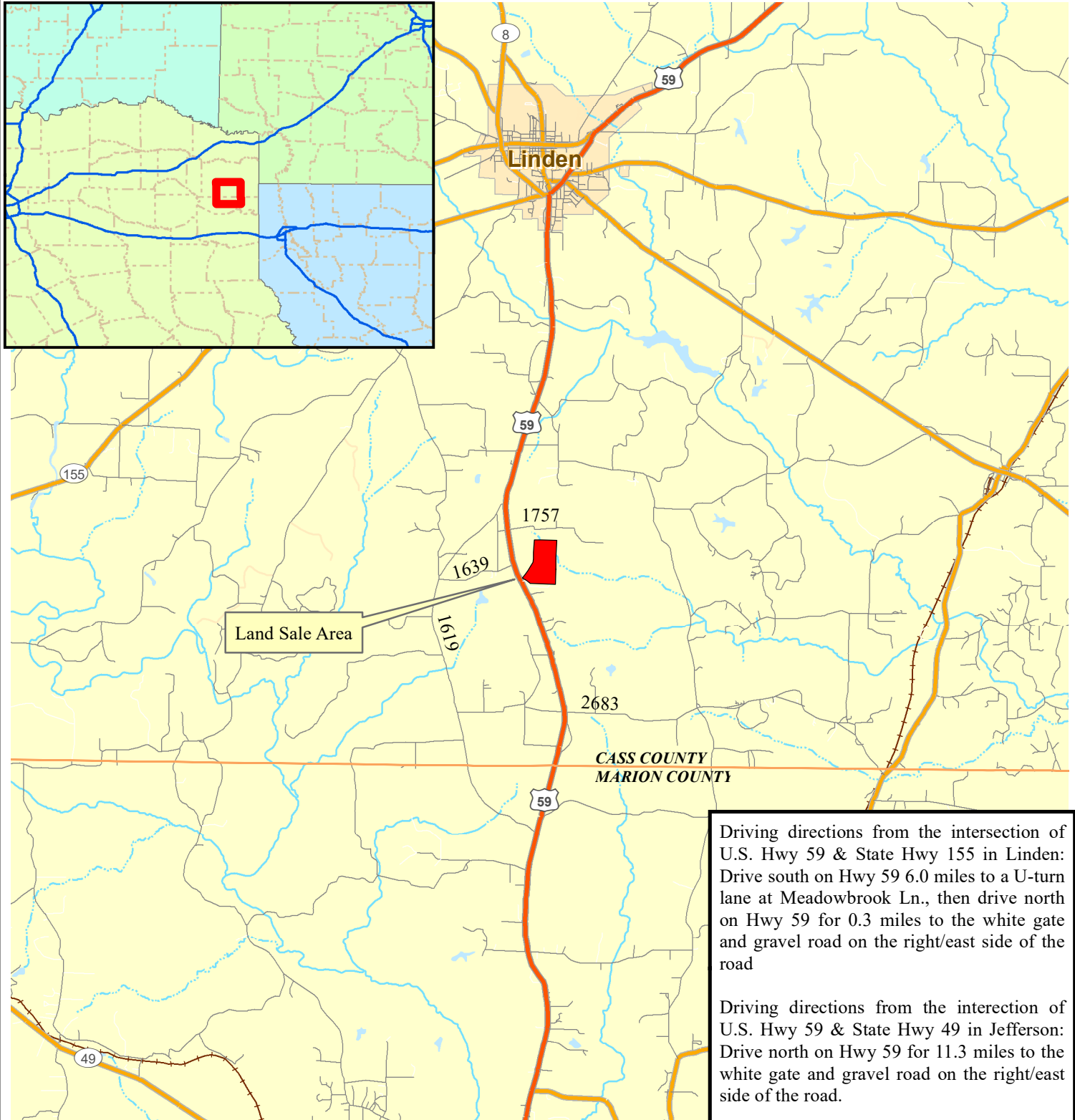
Conditions of Sale:

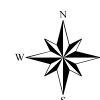
