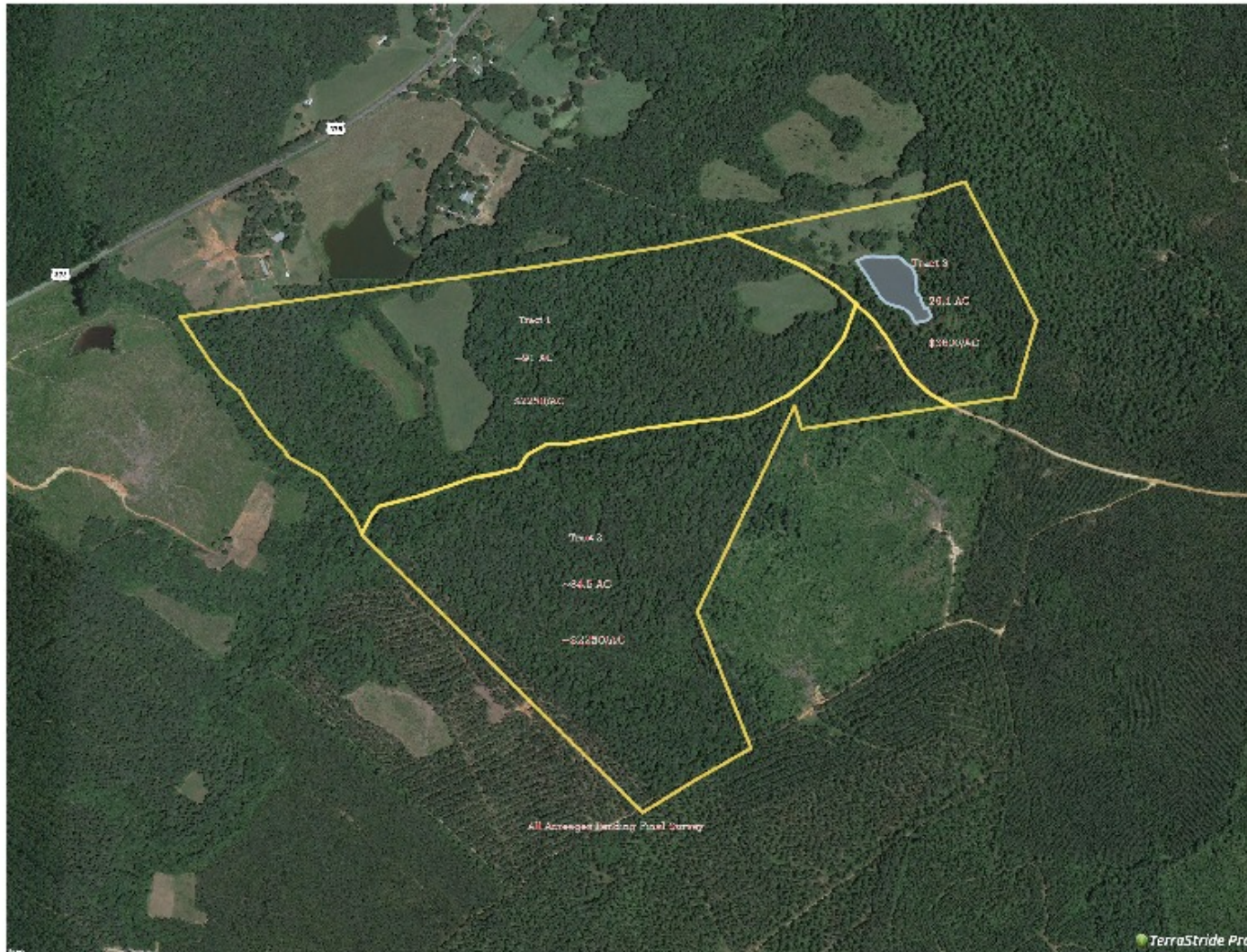

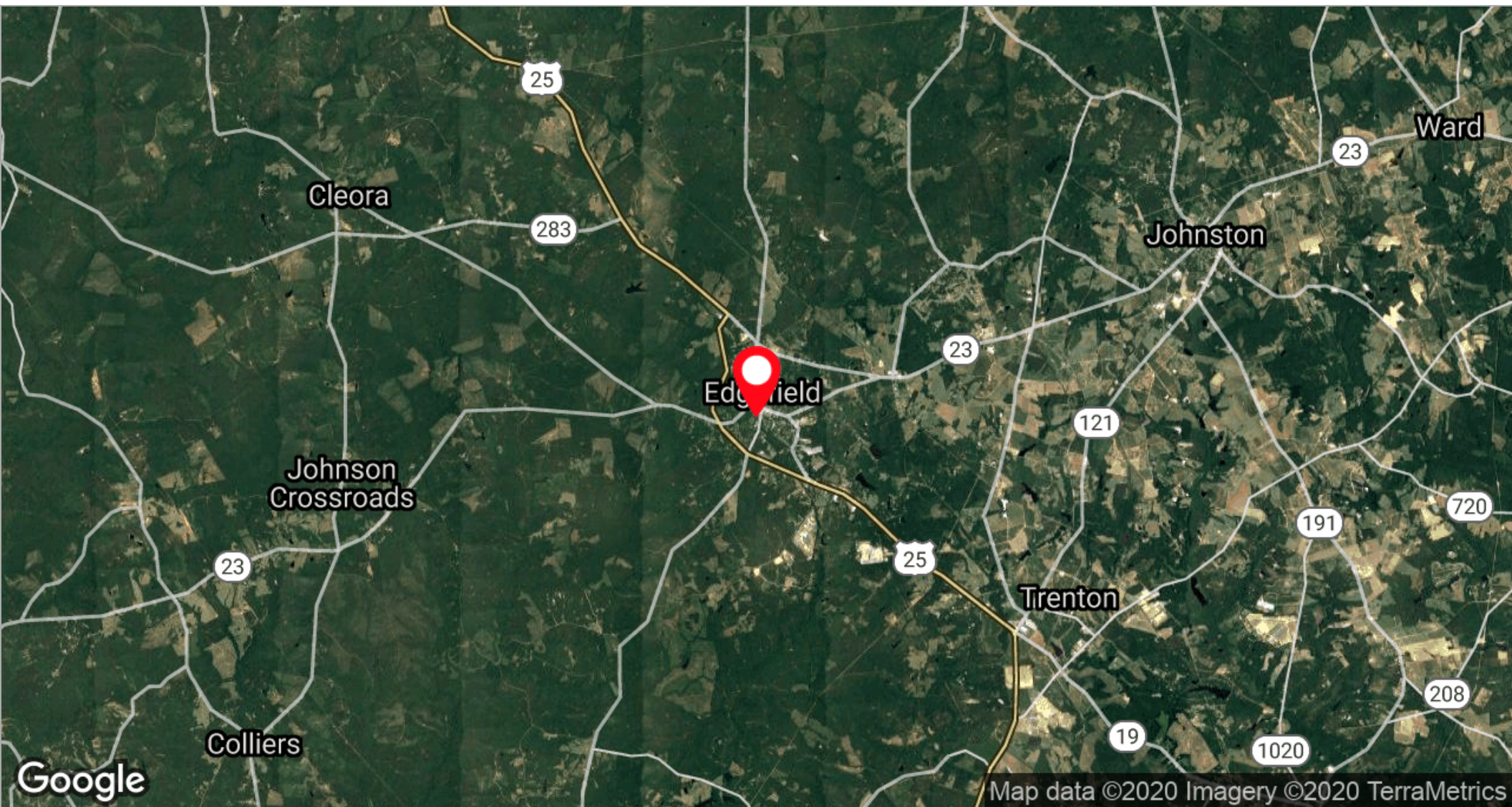

LOCATION MAPS

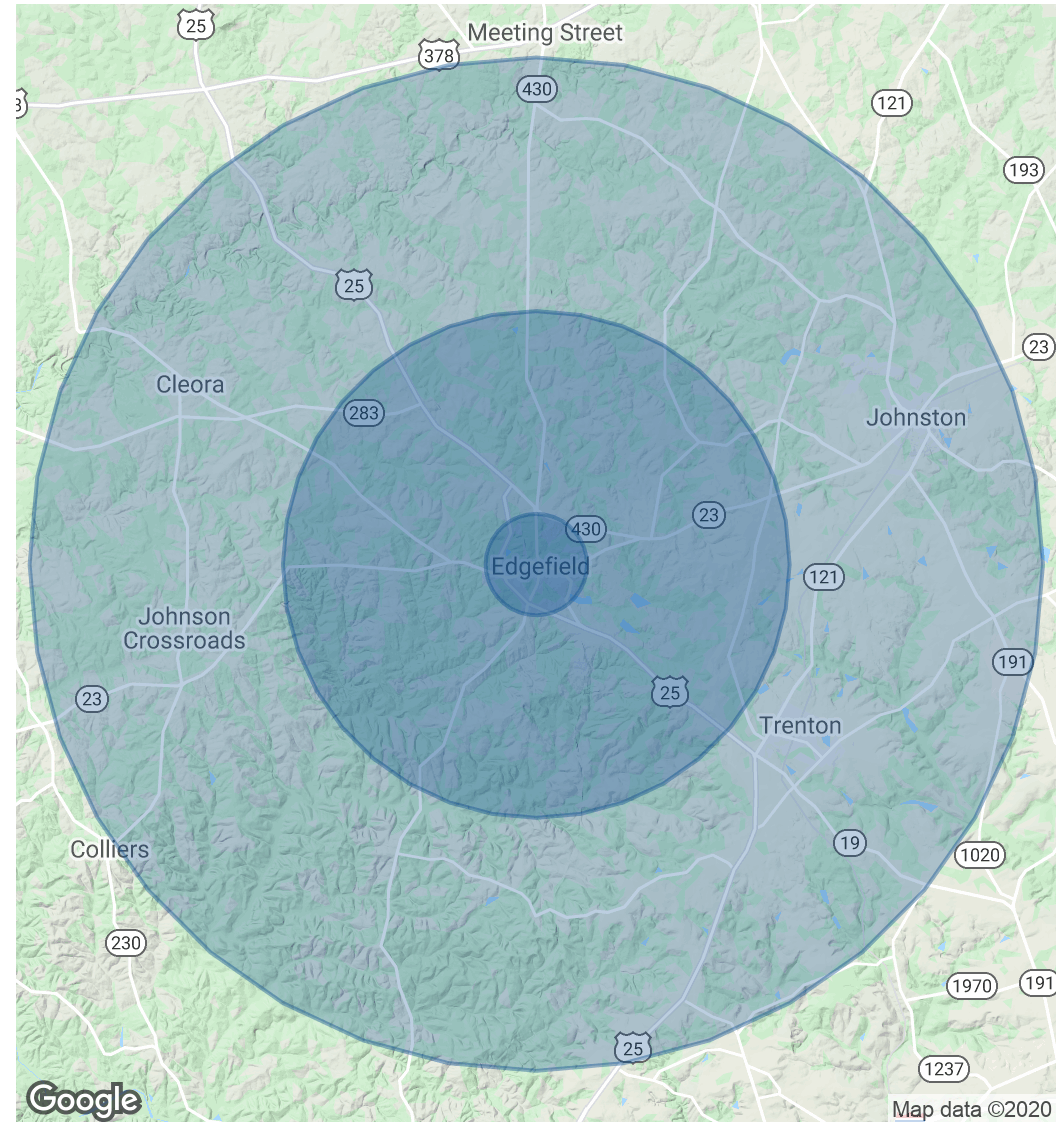
