ROAD MAINTENANCE AGREEMENT

ARNDER, are the owners of the property located along that private roadway known as "Simplicity Drive", located in South Fall Creek Township, Yadkin County, North Carolina, and being more completely described on that plat of survey prepared for Samuel and Patty Shermer, being duly recorded in Plat Book 9, Page 85, Yadkin County Registry, said road extending in a Westwardly direction from S.R. #1595, Union Cross Church Road, an approximate distance of 1,100 feet, more or less.

No expense shall be incurred by any party without unanimous consent of all other parties hereto. Such consent shall be in writing, signed by all parties, with a copy delivered to each party.

The Developer shall be responsible for their share of the cost of repair as long Developer owns Lot 3 and Lot 5. Once Lot 3 and Lot 5 have both sold, the Developer is no longer responsible for any maintenance of said private road. The Developer will require that the purchasers of Lot 3 and Lot 5 execute and assume their share of the Road Maintenance Agreement.

The undersigned hereby agree to jointly cooperate to maintain said private roadway in good repair, serviceable for all weather conditions, for the mutual benefit of all parties involved.
