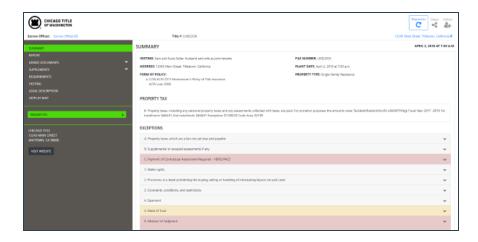



8. Payment of the real estate excise tax, if required.

If the transaction is exempt, an additional \$5.00 Affidavit Processing Fee is required.




