Subject to the limitations and exclusions on reverse side Window World Inc. ("Company") warrants to the original purchaser/property owner ("Owner") and, if any, Owner's immediate transferee, excluding all other subsequent transferees, that any basic window manufactured by the Company is free from defects in material and workmanship for as long as the Owner or Owner's immediate transferee resides in the home in which the windows are installed.

Vinyl Parts Warranty - That under normal use, the vinyl components of the window will not blister, peel, rot, or corrode.

Mechanical Parts Warranty That all mechanical parts (locks, vent locks, balances) are warranted to be free from manufactured defects in material and workmanship. Replacement parts will be supplied at no charge.

Insulated Glass Warranty - The sealed insulated glass unit is warranted against defects resulting in material obstruction of vision from film formation caused by dust or moisture in the dead air space of the sealed unit for the life of the window. If the glass unit fails, the Company will provide the Owner with a replacement insulated glass unit at no extra charge.

Glass Breakage Warranty - The Company will provide the Owner with a replacement insulated glass unit in the event of accidental glass breakage. Exclusions listed below apply.

Labor Warranty - That all labor necessary to correct any item covered by this warranty will be provided at no extra charge by the Company.

Transferable Warranty - This warranty may be transferred to the Owner's immediate transferee provided the transferee notifies the Company, in writing, at the address below, within 30 days of the property's transfer date. The correspondence must include a transfer fee of \$50, the original Owner's name and address, transferee's name and address, and the Window World location responsible for the installation.

LIMITED WARRANTY: ELK warrants to the original consumer purchaser ("Owner") that the Prestique shingles described below ("Shingles"): (1) are free from manufacturing defects that would adversely affect the performance of the Shingles; (2) will be resistant to blow-offs in wind velocities up to 60 miles per hour during the first five (5) years after installation, provided the thermal sealant has properly activated (SEE THE DETAILS IN THE SEPARATE LIMITED WIND WARRANTY SET FORTH BELOW); and (3) when manufactured with StainGuard® treatment. will inhibit the discoloration of roofing granules caused by growth of the blue-green algae, Gloeocapsa, which may adversely affect the appearance of roofs for the first five (5) years after installation. This Limited Warranty commences at the completion of the installation of the Shingles and continues for the warranty period described below.

The useful life of a given Shingle may be affected by many factors including: the weather conditions to which it is exposed; the quality of its installation; the type and quality of the construction, including the roof decking and ventilation; and other factors over which ELK has no control. This Limited Warranty describes your remedy in the event your Shingles are found to have defects in material or manufacturing workmanship which affect performance before the expiration of the stated warranty period. Any limited warranty does for assure that the covered products will last the entire length of the stated warranty period.

SOLE WARRANTY: THIS LIMITED WARRANTY IS EXCLUSIVE AND LIMITS AS TO DURATION ALL OTHER WARRANTIES WHETHER EXPRESS OR IMPLIED BY LAW, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, TO THE TIME PERIODS STATED BELOW. ELK MAKES NO REPRESENTATION OR WARRANTY OF ANY KIND, OTHER THAN THE LIMITED WARRANTY SET FORTH HEREIN, AND NO PERSON IS AUTHORIZED TO ALTER THIS LIMITED WARRANTY EITHER ORALLY OR IN WRITING. SOME STATES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU.

LIMITATION OF LIABILITY: This Limited Warranty is the sole and exclusive remedy provided to the Owner of the Shingles containing manufacturing defects affecting performance during the period specified below. To the extent of those Shingles actually containing defects in material or manufacturing workmanship which affect performance, ELK shall either: (1) pay the reasonable replacement cost of shingles and application labor, prorated as set forth below; or (2) provide replacement shingles only or pay the reasonable cost for replacement shingles of a similar design; or (3) pay the reasonable cost for repair of the Shingles. The decision on which remedy is used shall be at the sole discretion of ELK. After the first year, the replacement cost which ELK will pay will be reduced by the amount of usage you have received from your Shingles. ELK will therefore pay you a percentage of the reasonable replacement cost, described above, which will be calculated by dividing the number of months remaining in the warranty period by the number of months in the original warranty period. In the unlikely event the entire roof is found to be defective, ELK shall provide, or pay the reasonable replacement cost of, shingles and reasonable application labor to re-cover the roof. Any payment made by ELK shall be reduced by prorating as specified above for each month of the Owner's use of the Shingles. ELK, wherever possible, shall replace Shingles with shingles of the same color and design. However, since color variations exist between shingles manufactured at different times and since ELK may discontinue or modify its shingles, ELK reserves the right to replace defective Shingles with shingles of similar color and/or design. The application costs covered by this Limited Warranty do not include costs for tear-off, dump fees, flashing, metal work, underlayment or related work.

ELK SHALL NOT BE LIABLE FOR ANY INCIDENTAL, CONSEQUENTIAL, INDIRECT OR OTHER DAMAGES, INCLUDING ATTORNEYS' FEES. ELK SHALL NOT BE LIABLE BASED UPON ANY THEORY OF NEGLIGENCE, BREACH OF WARRANTY, STRICT LIABILITY, OR ANY OTHER THEORY. OTHER THAN THE LIMITED WARRANTY SET FORTH HEREIN. SOME STATES DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATIONS OR EXCLUSIONS MAY NOT APPLY TO YOU. THIS WARRANTY GIVES THE ORIGINAL OWNER SPECIFIC LEGAL RIGHTS, AND YOU MAY HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE.

LIMITED WIND WARRANTY: ELK'S LIMITED WARRANTY AGAINST BLOW-OFFS.

(A) APPLIES ONLY TO DAMAGE FROM WINDS UP TO 60 MILES PER HOUR. IN NO EVENT SHALL ELK BE LIABLE FOR ANY LOSS OR DAMAGE DUE TO WINDS IN EXCESS OF THE SPECIFIED 60 MPH WIND VELOCITY:

(B) IS CONDITIONED UPON APPLICATION IN ACCORDANCE WITH ELK APPLICATION INSTRUCTIONS PRINTED ON THE SHINGLE WRAPPER AND THE THERMAL SEALING OF THE SHINGLES INVOLVED. IN ORDER FOR SEALING TO OCCUR, THE SHINGLES MUST BE EXPOSED TO ADEQUATE HEAT FROM SURFACE TEMPERATURES OR SUNLIGHT. FAILURE OF A SHINGLE TO SEAL DUE TO INSUFFICIENT HEAT EXPOSURE IS NOT A MANUFACTURING DEFECT:

(C) SHALL APPLY ONLY DURING THE FIRST FIVE (5) YEARS AFTER INSTALLATION AND IS LIMITED TO ELK'S OBLIGATION TO PAY THE REASONABLE COST OF REPLACING SHINGLES THAT HAVE BLOWN OFF AND THE REASONABLE COST FOR MANUALLY SEALING ANY UNSEALED SHINGLES WHICH HAVE HAD ADEQUATE EXPOSURE TO HEAT. ELK'S LIABILITY FOR COVERAGE UNDER THIS LIMITED WIND WARRANTY SHALL TERMINATE AFTER FIVE (5) YEARS.

LIMITATION ON COVERAGE: ELK shall not be liable for, and this Limited Warranty does not apply to, any damages to the Shingles or any other property because of any reason other than the specific defects in materials or manufacturing workmanship defined in the Limited Warranty. The causes not covered by this Limited Warranty include, without limitation: (a) damage to the Shingles caused by acts of God, such as hailstorms and hurricanes; (b) damage to the Shingles caused by any distortion or movement of the roof deck, walls, or foundation of the building; (c) claims by subsequent owners or transferees. (THIS LIMITED WARRANTY IS PERSONAL TO THE ORIGINAL OWNER AND IS NOT ASSIGNABLE OR TRANSFERABLE UNDER ANY CIRCUMSTANCES); (d) application not in accord with the instructions printed on the Shingle wrapper; (e) damage to the Shingles caused by any application of cleaning solutions, paints, coatings or modifications of any kind; (f) damage to the Shingles caused by traffic (walking on the roof), misuse, neglect, or improper handling or use of the Shingles before, during or after installation; (g) damage to the Shingles caused by decking nails or staples backing out and either perforating or pushing up the Shingles; (h) damage to the Shingles caused by improper ventilation or drainage, or (i) variation in the color of Shingles within a batch and/or between batches ("Shading") which may occur from the positioning of the granular surfacing material used on the Shingles. Further, any expenses incurred for an unauthorized replacement or for the cost of replacement incurred prior to written acknowledgment of ELK's responsibility are not covered by this Limited Warranty and ELK shall not be responsible for any such expenses.

HOW TO MAKE A CLAIM: To request performance of any obligation asserted under this Limited Warranty, you must, within thirty (30) days of discovery of a problem, send written notification of the alleged defect with a copy of your warranty card and proof of purchase of the Shingles to ELK Corporation of Alabama at 4600 Stillman Boulevard, Tuscaloosa, Alabama, 35401, Elk Corporation of Texas at P.O. Box 500, Ennis, Texas 75120-0500, or 6200 Zerker Road, P.O. Bin C, Shafter, California 93263.

HOW CLAIM WILL BE HANDLED: Within a reasonable period of time from receipt of the claim, copy of warranty card and proof of purchase, ELK will review your letter and may ask for samples of the Shingles and photographs showing the extent of the problem. The Owner is responsible for providing these, and any other materials reasonably requested, at the Owner's expense. The Owner must allow reasonable time for investigation, including roof top inspection by an ELK employee and laboratory testing of the suspect product. ANY CLAIM FOR SHINGLES WHICH HAVE BEEN REPLACED PRIOR TO ELK'S RECEIPT OF WRITTEN NOTICE AND ON-SITE INSPECTION SHALL BE DENIED. If the investigation reveals manufacturing defects covered by this Limited Warranty, ELK will provide, within a reasonable period of time, a settlement in accordance with the conditions of the Limited Warranty.

Due to the nature of this type of work, customers need to understand that as we schedule the start dates we reserve a two to three day window on both sides of the start date since we can not foresee all potential problems on the house being rewired prior to the next scheduled house. Customers that want to take time off from their work should be aware of a possible early or late start date. We rarely damage drywall while performing a rewire on one story ranch style homes that have adequate attic space so our technicians can get to the wires. Two and three story homes are a little different in the fact that some wires are routed between floor levels where we are not able to access them from the top or from the bottom without cutting the drywall. Even though we put great thought and care into the way we rewire, owners of multi-story homes should be aware that some drywall cutting will need to be done. The extent of drywall cutting is based on the construction of the home and the original way in which it was wired. In the event we have to cut drywall, we will repair our cuts in the drywall to match the existing texture of the area as closely as we can. Prices quoted for two story homes do not include the patch work as we are unable to predetermine the amount of /or number of patches required. However, we do not prime nor paint the repaired areas. This quote is valid for the next 30 days, after which values may be subject to change. All material is guaranteed to be as specified.
